## ASSIGNMENT AGREEMENT

In consideration of One Dollar (\$1.00) and of other good and valuable consideration paid to the Assignor by the Assignee, receipt whereof is hereby acknowledged, the Assignor does hereby sell, assign, set over and quit all claim unto the Assignee her entire right, title and interest in Canada, the United States and all other countries and territories in and to the said Applications and in and to the said Inventions inclusive of any and all priority rights derived therefrom, including all past and future income, royalties, damages and payments due (including, rights to damages and payments for past, present or future infringements or misappropriations) with respect thereto, in each case, of the Assignor in all countries relating to such Applications and Inventions, free and clear of all liens, claims and encumbrances, the same to be held and enjoyed by the Assignee, her successors, assigns or legal representatives to the full ends of the terms for which all Letters Patent or Registered Designs therefor may be granted including any extensions or reissues thereof as fully and entirely as the same would have been held and enjoyed by the Assignor if this assignment and quit claim had not been made.



**THE ASSIGNOR HEREBY COVENANTS AND AGREES** that she will execute or procure any further necessary assurance of the title to the Inventions and Letters Patent or Registered Designs that may be granted therefor and that she will at any time upon the request and at the expense of the Assignee execute and deliver any and all papers that may be necessary or desirable for the Assignee to make application for Letters Patent or Registered Designs in any country or territory for the said Inventions or to perfect the title to said Inventions or any Letters Patent or Registered Designs which may be granted therefor to the Assignee, her successors, assigns, or other legal representatives and that she will at any time upon the request and at the expense of the Assignee testify in any legal proceeding, sign all lawful papers, execute any additional divisional, substituting, continuing or reissue applications for Letters Patent or Registered Designs for the said Inventions or any part or parts thereof, make all rightful oaths and generally do all lawful acts to enable the Assignee, her successors, assigns or other legal representatives to acquire title to and to obtain and enforce patent, design or any other form of intellectual property protection in or for the said inventions, and any and all changes, modifications or improvements to the said inventions now existing or made hereafter, in all countries and territories without further compensation but at the expense of the Assignee, her successors, assigns or other legal representatives. If the Assignor is unavailable, unable or unwilling to fulfill any of her obligations under

or pursuant to this Assignment Agreement, the Assignor hereby irrevocably names and appoints the Assignee with full Power of Attorney to sign all lawful papers and applications as contemplated by this Assignment Agreement for and on behalf of the Assignor for the purpose of aiding the Assignee, her successors, assigns or other legal representatives to obtain and enforce patent, design or any other form of intellectual property protection in or for the said inventions in all countries and territories.


