PATENT SECURITY AGREEMENT

PATENT SECURITY AGREEMENT (this "<u>Agreement</u>"), dated as of December 21, 2022, by the undersigned (the "<u>Grantor</u>"), in favor of ALLY BANK, as administrative and collateral agent for the Lenders (in such capacities, "<u>Agent</u>").

WITNESSETH:

WHEREAS, pursuant to that certain Loan Agreement (as amended, restated, extended, supplemented or otherwise modified in writing from time to time, the "Loan Agreement"), dated as of December 21, 2022 and entered into among CMI INTERCO, LLC, a Delaware limited liability company, as Holdings (as defined in the Loan Agreement), the other Loan Parties (as defined in the Loan Agreement) from time to time party thereto, the Lenders from time to time party thereto and Agent; and

WHEREAS, pursuant to the Loan Agreement, the Grantor is required to execute and deliver to Agent, for the benefit of itself and the Secured Parties, this Agreement.

NOW, THEREFORE, in consideration of the premises and mutual covenants herein contained and for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Grantor hereby agrees as follows:

- 1. <u>DEFINED TERMS</u>. Unless otherwise noted, all capitalized terms used but not otherwise defined herein have the meanings given to them in the Loan Agreement, and this Agreement shall be subject to the rules of construction set forth in <u>Section 1</u> of the Loan Agreement, which rules of construction are incorporated herein by this reference, *mutatis mutandis*.
- 2 GRANT OF SECURITY INTEREST IN PATENT COLLATERAL. To secure the payment and performance of the Obligations under the Loan Agreement, the Grantor hereby grants to Agent, for the benefit of itself and the Secured Parties, a security interest in: (i) all of the Grantor's now existing or hereafter acquired rights, title and interests in and to all of Grantor's patents and patent applications, including (a) the patents and patent applications listed on Schedule I hereto as owned by Grantor (collectively, the "Patents"); (b) all continuations, divisionals, continuations-in-part, re-examinations, reissues, and renewals thereof and improvements thereon; (c) all income, royalties, damages and payments now and hereafter due or payable under and with respect thereto, including payments under all licenses entered into in connection therewith and damages and payments for past, present, or future infringements thereof; (d) the right to sue for past, present, and future infringements thereof; and (e) all of Grantor's rights corresponding thereto throughout the world; (ii) any claim by Grantor against third parties for past, present or future infringement of any Patent or any Patent exclusively licensed under any license with respect thereto, including the right to receive damages, or right to receive license fees, royalties, and other compensation under any license with respect thereto (all of the foregoing are collectively referred to herein as the "Patent Collateral").

Notwithstanding the foregoing, the security interest granted herein does not include any Excluded Property (as defined in the Security Agreement).

- 3. <u>SECURITY AGREEMENT</u>. The security interests granted pursuant to this Agreement are granted in conjunction with the security interests granted to Agent, for the benefit of the Secured Parties, pursuant to the Security Agreement. The Grantor hereby acknowledges and affirms that the rights and remedies of Agent with respect to the security interest in the Patent Collateral made and granted hereby are more fully set forth in the Security Agreement, the terms and provisions of which are incorporated by reference herein as if fully set forth herein.
- 4. <u>REPRESENTATIONS AND WARRANTIES</u>. The Grantor hereby represents and warrants that the patents and patent applications listed on <u>Schedule I</u> attached hereto constitute all U.S. federally registered patents and patent applications registered to the Grantor as of the date of this Agreement.
- 5. <u>COUNTERPARTS</u>. This Agreement (and any amendments, waivers, consents, or supplements hereto) may be executed in counterparts (and by different parties hereto in different counterparts), each of which shall constitute an original, but all of which when taken together shall constitute a single instrument. Delivery of an executed counterpart of a signature page of this Agreement by facsimile or in electronic (i.e., "<u>pdf</u>" or "<u>tif</u>") format shall be effective as delivery of a manually executed counterpart of this Agreement.
- 6. <u>GOVERNING LAW, JURISDICTION AND WAIVER OF JURY TRIAL</u>. THIS AGREEMENT SHALL BE SUBJECT TO THE PROVISIONS REGARDING GOVERNING LAW, JURISDICTION AND WAIVER OF JURY TRIAL SET FORTH IN <u>SECTIONS 10.13</u>, <u>10.14</u> AND <u>10.17</u> OF THE LOAN AGREEMENT, AND SUCH PROVISIONS ARE INCORPORATED HEREIN BY THIS REFERENCE, *MUTATIS MUTANDIS*.
