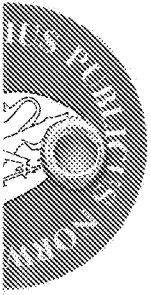

**CONFIRMATORY ASSIGNMENT OF  
PATENT APPLICATIONS, GRANTED PATENTS AND  
RELATED WORLDWIDE RIGHTS**

**THIS DEED OF CONFIRMATORY ASSIGNMENT** is made the                      day                      of  
2021

**BETWEEN**

- (1) **Norner Verdandi AS**, a company incorporated in Norway (Company No. 995 419 726) with offices situated at Asdalstrand 291, 3960 Stathelle, Norway (the “Assignor”); and
- (2) **Norner AS**, a company incorporated in Norway (Company No. 898 736 032) whose registered office is situated at, Asdalstrand 291, 3960 Stathelle, Norway (the “Assignee”).

**BACKGROUND**

- (A) The Assignor was acquired by the Assignee under a merger agreement (“Meerger Agreement”) which took effect on 29 November 2021 (“Effective Date”) and provided for the transfer of all assets owned by the Assignor to the Assignee.
- (B) The Assignor confirms that such transfer includes the assignment to the Assignee of the patent applications and granted patents (and the inventions claimed therein) (collectively “Patent Rights”) detailed in the Schedule upon the terms and conditions set out below.

**OPERATIVE PROVISIONS**

1. In consideration of the sum of £1 paid by the Assignee to the Assignor (the receipt and sufficiency of which the Assignor hereby acknowledges) the Assignor **HEREBY CONFIRMS THE ASSIGNMENT** with full title guarantee as at the Effective Date to the Assignee of:
  - (a) the Patent Rights and the full and exclusive benefit of them;

- (b) all the rights of the Assignor in and to the Patent Rights and the full and exclusive benefit of them and all rights privileges and advantages associated with them;
- (c) the full right to apply for and obtain patents or other similar forms of protection in respect of the Patent Rights throughout the world;
- (d) the right to make any new application or applications anywhere in the world in respect of any part or parts of the subject matter of any application or specification filed in connection with the Patent Rights;
- (e) any patents or other similar forms of protection granted in respect of the Patent Rights;
- (f) the right to claim priority of the Patent Rights; and
- (g) the right to bring proceedings (anywhere in the world) for the recovery of damages and/or other remedies in respect of any previous infringement of the rights assigned by this Assignment

TO HOLD the same unto the Assignee absolutely.

2. The assignment herein is confirmatory only and does not supersede or derogate from the operative assignment implemented by the Merger Agreement.
3. The Assignor hereby covenants with the Assignee that it shall execute such further documents and do such further acts, and shall procure on the part of the inventors of the Inventions the execution and doing of all such further documents and acts, as may reasonably be required by the Assignee to enable the Assignee (or its nominee) to enjoy the full benefit of the property and rights hereby assigned and to apply for any patents or other forms of protection in respect of the Patent Rights throughout the world, and fully and effectively to vest the same in the Assignee or as the Assignee shall direct.
4. The Assignor further covenants with the Assignee that at the request and expense of the Assignee it shall provide all such assistance as the Assignee may reasonably

require in connection with any proceedings concerning the Patent Rights or any patents, patent applications or similar rights applied for or arising in respect of the Inventions, including the disclosure of relevant documents and materials and the provision of oral and written testimony from relevant personnel.

5. This Assignment shall be governed by and construed in accordance with English law and shall be subject to the exclusive jurisdiction of the English courts.


