NUNC PRO TUNC PATENT AND TRADEMARK ASSIGNMENT

The Parties acknowledge and agree that Assignee is a successor to the business of the Assignor, or to portion(s) of the business of Assignor, to which the Trademarks pertain.

Assignor hereby sells, assigns, transfers, and conveys to Assignee, its successors and assigns, *nunc pro tunc* effective as of September 16, 2022, Assignor's entire worldwide right, title, and interest in and to the patent application and the patent on Exhibit B, together with all inventions therein, together with all present and future patent applications and patents claiming priority, to or from, in whole or in part, the foregoing (collectively the "Patents"), and together with all claims, demands, rights, and causes of action, in law, in equity, or otherwise, arising out of past, present and future infringement or unauthorized use of the Patents or the inventions therein, including all damages recoverable thereby and remedies related thereto.

Assignor further covenants and agrees that it and its representatives will, at Assignee's request and expense, do all other lawful acts necessary to enable Assignee to obtain, maintain and enforce full the benefits of the rights and interests herein sold, assigned, transferred, and conveyed. This Agreement shall be binding on the successors and assigns

of Assignor and shall inure to the benefit of the successors and assigns of Assignee. This Agreement may be executed in counterparts. This Agreement constitutes the complete understanding of the parties on the subject matter hereof and replaces and supersedes all prior agreements, communications, and documents with respect to such subject matter.

Assignor represents and warrants that it owns all right, title, and interest in and to the Trademarks and the Patents, that it has the authority to transfer all of the rights sold, assigned, transferred, and conveyed pursuant to this Agreement, and that it has not licensed anyone to use the Trademarks or the Patents in any way.

Assignor hereby waives and forfeits any and all rights it presently has, or in the future may have, to challenge or interfere with the validity and/or enforceability of the Trademarks or the Patents, including but not limited to challenges in a court, before a patent or a trademark office, or before any other body, agency, or entity.


