## CONFIRMATORY PATENT ASSIGNMENT

This Confirmatory Patent Assignment (this "Assignment") is entered into as of the last date noted below, by and between Protect-A-Bed, LLC, a Limited Liability Company established under the laws of Delaware, having its registered office at 901 W Yamato Road, Suite 250, Boca Raton, Florida, 33431, (the "Assignor"), and Bedding Acquisition, LLC, a Limited Liability Company established under the laws of Delaware, having its registered office at 60 E 42<sup>nd</sup> Street, #1250, New York, New York 10165 (the "Assignee"). Assignor and Assignee are collectively referred to as the "Parties" and individually referred to as a "Party."

WHEREAS, pursuant to an INTELLECTUAL PROPERTY TRANSFER AGREEMENT dated April 12, 2021 (the "Prior Agreement"), Assignor assigned, transferred and conveyed all of its right, title and interest in and to, *inter alia*, (i) all of the patents and patent applications identified on Schedule A of this Assignment (the "Patents") to Assignee, (ii) the right, title and interest in and to any and all divisional, continuation, substitute or reissue applications pertaining to the Patents, (iii) patents applied for or granted worldwide pertaining to the Patents and (iv) the right to sue and collect past damages in connection with the Patents, in the United States and throughout the world (i-iv collectively referred to as the "Patent Rights"), and Assignee agreed to accept the Patent Rights.

NOW, THEREFORE, with acknowledgement by the Parties of the receipt and exchange of valuable and sufficient consideration associated with the Prior Agreement, the receipt and sufficiency of which is hereby acknowledged, the Parties hereby agree as follows:

1. To confirm the above-noted assignment pursuant to the Prior Agreement, as of April 12, 2021, *nunc pro tunc*, Assignor hereby assigns, transfers, conveys and sets over to the Assignee, its successors and assigns, and Assignee hereby accepts, all right, title and interest, in the United States and throughout the world, in and to the Patent Rights, to have and to hold the same, unto Assignee for its own use and enjoyment and for the use and enjoyment of its successors and assigns, for the full term or terms of all such rights. The assignment of the Patents shall include the right to file domestic patent applications under the laws of the United States and all other countries that claim the benefit of any of the foregoing applications, and to file foreign patent applications in the name of the Assignee or its affiliates, wherever such right may be legally exercised, and all rights under any International Conventions for the Protection of Industrial Property, including the Paris Convention and the European Patent Convention and the corresponding rights to claim benefit from the priority of such applications.

2. Assignor hereby authorizes and requests the United States Commissioner of Patents, and the Patent Office officials in foreign countries as are duly authorized by the respective foreign patent laws to issue patents, to issue any and all patents within the Patent Rights to the Assignee as the owner thereof.

3. Assignor hereby agrees, without further consideration and without expense to the Assignor, to sign all documents and to perform all other lawful acts which the Assignee may reasonably request to make this Assignment of the Patent Rights fully effective. Assignor hereby also declares that Assignee may take any steps for recordal of this Assignment in the sole name of the Assignee.

4. This Assignment shall be binding upon, inure to the benefit of, and be enforceable by, the Parties and their respective successors and permitted assigns.

5. This Assignment may be executed and delivered (including electronically) in one or more counterparts, and by the Parties in separate counterparts, each of which when executed shall be deemed to be an original, but when taken together shall constitute one and the same agreement.

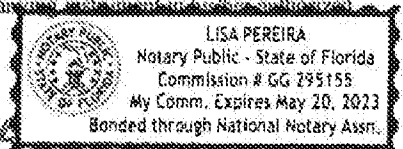

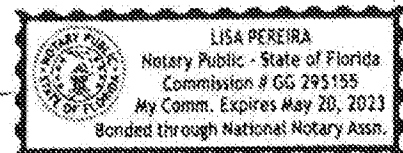
