The ASSIGNOR represents and warrants that ASSIGNOR is the sole and exclusive lawful owner of all rights, title, and interest in and to the PATENT; that the PATENT have not been assigned or otherwise transferred, encumbered or affected by ASSIGNOR; and that the ASSIGNOR has the authority and full right to make this ASSIGNMENT.






