

ASSIGNMENT OF PATENT RIGHTS

Assignor hereby irrevocably assigns, transfers, conveys and delivers to Assignee, and Assignee hereby accepts, all of Assignor's rights, titles, and interests, throughout the world, in and to the following (collectively, the "Assigned Patent Rights"): (a) all Patent Assets, and any and all patents issuing therefrom in the United States and in any foreign country(ies), including, without limitation, any and all reissues, reexaminations, registrations, revalidations, additions, supplementary protection certificates, certificates of correction, renewals, and extensions thereof or therefor; (b) all inventions and discoveries claimed or otherwise disclosed in the Patent Assets (collectively, the "Inventions"); (c) all patent applications, including, without limitation, utility patent applications, design patent applications, provisionals, non-provisionals, divisionals, continuations, continuations-in-part, substitutions, applications for industrial property protection, utility models, inventors' certificates, and industrial designs, which have been or may be filed in the United States, in any foreign country(ies), or internationally, for or in connection with, or that otherwise claim or may claim priority to or the benefit of, any of the Patent Assets and/or the Inventions, and all patents issuing therefrom in the United States and in any foreign country(ies), including, without limitation, any and all reissues, reexaminations. registrations, revalidations, additions, supplementary protection certificates, certificates of correction, renewals, and extensions thereof or therefor; (d) all rights to file, prosecute, receive and secure, exclusively and directly in the name of Assignee, each of the patent applications, patents, and other patent-related filings referenced in Sections 1(a) through 1(c) (inclusive) hereof, and to claim any benefits, priority rights or other rights to which any of the foregoing are or may be entitled, in each case under the patent laws of the United States, the patent laws of any foreign country(ies), the Paris Convention for the Protection of Industrial Property, the Patent Cooperation Treaty, or any other international agreement, treaty, law or convention, or the domestic rules, laws, statutes or regulations of any country(ies); and (e) all of Assignor's other rights, titles, interests, privileges and protections of any kind or nature whatsoever, that, in each case, have accrued, are accruing, or may accrue under any of the foregoing pursuant to any applicable law, rule, statute, regulation, convention or treaty, and that, in each case, existed, exists, or may come into existence, anywhere in the world.

- 3. All Assigned Patent Rights are to be held and enjoyed by Assignee and Assignee's successors and assigns as fully and exclusively as they would have been held and enjoyed by Assignor had this Assignment not been made. Assignor will do, and will cause to be done, all acts serving to ensure that the Assigned Patent Rights are held and enjoyed by Assignee and Assignee's successors and assigns as fully and exclusively as they would have been held and enjoyed by Assignor had this Assignment not been made. Without limiting the generality of the foregoing, at the request of Assignee or its successors or assigns, Assignor shall: (a) execute and deliver, and cause to be executed and delivered, to Assignee all lawful documents (including, without limitation, any and all petitions, affidavits, declarations, oaths, assignments, affirmations of assignment, powers of attorney, deeds, bills of sale, instruments of assumption, instruments of recordation, or other instruments, in form and in substance as requested by Assignee), and take all such other actions, as may be necessary or prudent to (i) effect, evidence, affirm, perfect, register, or record this Assignment, or the assignment to Assignee (or any of its successors or assigns) of any of the Assigned Patent Rights, (ii) prosecute, register, maintain, administrate, or enforce any of the Assigned Patent Rights, or (iii) effect the intent and purposes of this Assignment (including without limitation the implementation and recordation of the transactions as contemplated by this Assignment), in each case for the benefit of Assignee or any of its successors or assigns; (b) furnish to Assignee (and, as applicable, any of its successors or assigns) all facts relating to the Assigned Patent Rights and all file histories therefor, and all documents, information, photographs, models, samples, prototypes, physical exhibits, and other evidence establishing or otherwise pertaining to the conception and reduction to practice of any of the Assigned Patent Rights; and (c) fully cooperate with and otherwise assist Assignee (and, as applicable, any of its successors or assigns) in any proceedings relating to any such Assigned Patent Rights (including, without limitation, by providing any documents, testimony or other evidence in any such proceedings), whether before the United States Patent and Trademark Office, any foreign office, any governmental office or administrative agency, or any other legal entity or body whatsoever.

Assignor hereby irrevocably designates and appoints Assignee and its duly authorized officers and agents as its agents and attorneys in fact, coupled with an interest, to act for and on its behalf and in its stead to execute and file any documents and to do all other lawfully permitted acts to effect, evidence, affirm, perfect, register, or record Assignee's rights under this Assignment, with the same legal force and effect as if executed by Assignor or any of its successors, legal representatives or assigns. To that end, Assignor hereby grants Assignee and its duly authorized representatives the power to insert on this Assignment any further identification which may be necessary or prudent in order to comply with the rules of the United States Patent and Trademark Office, any foreign office, any governmental office or administrative agency, or any other legal entity or body whatsoever, for recordation and enforcement of this Assignment.
- 5. Assignor hereby authorizes and requests the United States Commissioner for Patents, and all similarly situated foreign officials, to issue any and all patent(s) resulting from any and all patent application(s) (of, for, or otherwise pertaining to, any of the Assigned Patent Rights) to Assignee, pursuant to the terms of this Assignment.

- 6. Assignor hereby covenants that it has the full right and authority to assign, transfer, convey and deliver to Assignee the Assigned Patent Rights, and that Assignor has not executed, and will not execute, any agreement(s) in conflict herewith. To that end, Assignor hereby further covenants that the Assigned Patent Rights are not encumbered by any grant, license, or other right heretofore given. To the extent any of the Assigned Patent Rights have been sold, assigned, transferred, conveyed and delivered to Assignee via another instrument, this Assignment shall operate as an affirmation of such sale, assignment, transfer, conveyance and delivery of the Assigned Patent Rights to Assignee.
- 7. This Assignment, and the rights, titles, interests, duties and obligations hereunder, are freely assignable by Assignee in whole or in part. The duties and obligations of Assignor under this Assignment may not be assigned, delegated or transferred without the prior written consent of Assignee. This Assignment shall inure to the benefit of Assignee and its successors, assigns and other legal representatives, and shall be binding upon Assignor and its successors, assigns and other legal representatives.
- 8. This Assignment may be executed in one or more counterparts, each of which shall be deemed an original, but all of which together shall constitute one and the same instrument.
