ASSIGNMENT OF INTELLECTUAL PROPERTY

Pursuant to and in accordance with the provisions and conditions of that certain Asset Purchase Agreement, dated as of January 30, 2020, by and among Assignor, Billing Services Group Limited, a Bermuda corporation ("Parent") and Assignee (the "Purchase Agreement"), and for consideration therein specified, the adequacy and sufficiency of which are acknowledged, Assignor does hereby sell, convey, transfer, assign and deliver to Assignee, free and clear of all Liens (as such term is defined in the Purchase Agreement), and Assignee does hereby purchase and acquire from Assignor, all of Assignor's right, title and interest in, to and under: all of the Assets constituting Owned Intellectual Property, including without limitation, the Patents listed on Schedule A hereto, the Trademarks listed on Schedule B hereto, the Wireless Base Code and the Intellectual Property Rights (as such terms are defined in the Purchase Agreement) therein (for the purposes of this Assignment, all of the foregoing are collectively hereinafter referred to as the "Intellectual Property Assets"); together with the goodwill associated with all trademarks included within the Trademarks.

The representations, warranties, covenants, agreements and indemnities contained in the Purchase Agreement shall not be superseded hereby but shall remain in full force and effect to the full extent provided therein. In the event of a conflict between the terms of this Assignment and the Purchase Agreement, the terms of the Purchase Agreement shall control.

In case any further action is necessary or desirable to carry out the purposes of this Assignment, Assignor shall (a) at any time take such further action (including the execution and delivery of such further instruments and documents) as Assignee may reasonably request, and (b) during the twelve (12) months following the date hereof, provide any facts relating to the Intellectual Property Assets or the history thereof known to them as Assignee may reasonably request, and Assignee shall reimburse Assignor for Assignor's out-of-pocket expenses incurred by Assignor to do so (unless Assignee is entitled to indemnification therefor pursuant to the Purchase Agreement).

A signed copy of this Assignment delivered by facsimile, email or other means of electronic transmission shall be deemed to have the same legal effect as delivery of an original signed copy of this Assignment.


This Assignment shall be governed by and construed in accordance with the internal laws of the State of Delaware applicable to agreements made and to be performed entirely within such State, without regard to the conflicts of law principles of such State.
