UPON SAID CONSIDERATION, ResMed hereby covenant and agree with ResMed Paris that ResMed have not and will not execute any writing or do any act whatsoever conflicting with these presents, and that ResMed will, at any time upon request, without further or additional consideration, but at the expense of ResMed Paris, execute such additional assignments and other writings and do such additional acts as ResMed Paris may deem necessary or desirable to perfect ResMed Paris's or its assign's enjoyment of this



This Confirmation of Assignment may be executed in any number of counterparts and the executed counterparts together constitute an original.


