## **INTELLECTUAL PROPERTY ASSIGNMENT**

This Intellectual Property Assignment (this “***Assignment***”), effective as of November 13, 2020 (the “***Effective Date***”), is by and between Thuuz, Inc., a Delaware corporation (the “***Assignor***”) and STATS LLC, a Delaware limited liability company (“***Assignee***”). Each of the parties is referred to individually as a “***Party***,” and collectively as the “***Parties***.”

The Parties have entered into that certain Asset Purchase Agreement, dated on or about the Effective Date (the “***Purchase Agreement***”), pursuant to which Assignor has agreed to assign to Assignee all Intellectual Property owned by Seller, including the patents and patent applications set forth in Attachment A (the “***Patents***”), the registered trademarks and trademark applications set forth in Attachment B (the “***Trademarks***”) and the registered domain names set forth in Attachment C (the “***Domain Names***”).

In consideration of the promises and covenants set forth in this Assignment and in the Purchase Agreement, the Parties agree as follows:

1. **Definitions.** Capitalized terms used but not defined herein or below shall have the meanings ascribed to such terms in the Purchase Agreement:

(a) “***Acquired Intellectual Property***” means all Intellectual Property owned by the Assignor, and the right to sue, and collect damages for, past, present or future, infringement, dilution or other violation of the foregoing.

(b) “***Intellectual Property***” means all right, title and interest in or relating to intellectual property, whether protected, created or arising under the laws of the United States or any other jurisdiction, including: (i) patents and applications therefor, including continuations, divisionals, and continuations-in-part thereof and patents issuing thereon, along with all reissues, reexaminations and extensions thereof, (ii) trademarks, service marks, trade names, service names, brand names, trade dress rights, corporate names, trade styles, logos and other source or business identifiers and general intangibles of a like nature, together with the goodwill associated with any of the foregoing, along with all applications, registrations, renewals and extensions thereof, (iii) Internet domain names, (iv) copyrights and mask work, database and design rights, whether or not registered or published, all registrations and recordations thereof and all applications in connection therewith, along with all reversions, extensions and renewals thereof, (v) trade secrets and other proprietary Confidential Information, and (vi) other intellectual property rights arising from or relating to Technology..

2. **Assignment.** Assignor hereby, absolutely and unconditionally, conveys, sells, assigns, transfers, grants and sets over unto the Assignee, all of the Assignor’s right, title and interest and benefit in and to the Acquired Intellectual Property, including the Patents, Trademarks and Domain Names, together with the right to all past, present and future income, royalties, damages and payments due with respect to the foregoing and all rights of action, both at law and in equity with respect thereto, including all rights to sue, settle any claim, and collect all damages for any past, present, or future infringement or misappropriation of the Acquired

Intellectual Property (including the Patents, Trademarks and Domain Names), including the goodwill of the businesses connected to the use of any of the Acquired Intellectual Property, in all cases free and clear of all Liens, the same to be held and enjoyed by the Assignee, its successors and assigns forever, as fully and entirely as the same could have been held and enjoyed by the Assignor if this assignment had not been made and the Assignee does hereby accept such sale, assignment, transfer, grant, conveyance and set over.

3. Absolute Conveyance. The conveyance of the Acquired Intellectual Property (including the Patents, Trademarks and Domain Names) hereunder is an absolute transfer to Assignee.

4. Further Assurances. After the Effective Date, the Parties shall execute and deliver such other certificates, agreements, conveyances and other documents, and take such other action, as may be reasonably requested by the other Party in order to complete the sale, assignment, transfer and conveyance to Assignee of all of the right, title and interest of Assignor in, to and under the Acquired Intellectual Property (including the Patents, Trademarks and Domain Names) hereby sold, assigned, transferred or conveyed, or intended so to be. Specifically, as to Assignor, Assignor hereby covenants and agrees that Assignor will communicate to Assignee, its successors, legal representatives and assigns, any material facts, documentation and records (including information relating to use or non-use, prosecution, enforceability, or infringement of the Acquired Intellectual Property, including the Patents, Trademarks and Domain Names) known to Assignor with respect to the Acquired Intellectual Property (including the Patents, Trademarks and Domain Names) and testify in any legal proceeding, sign all lawful papers, execute all applications (including, but not limited to, powers of attorney, specific assignments, transfers and assurances), make all rightful oaths and use reasonable best efforts at the request of the Assignee to aid the Assignee, its successors, legal representatives and assigns in obtaining and enforcing protection for the Acquired Intellectual Property (including the Patents, Trademarks and Domain Names) and in enjoying the full benefits thereof. Without limiting the generality of the foregoing, Assignor will, as promptly as possible following the closing (i) cause its legal representatives to provide reasonable assistance to Assignee, including, if requested by Assignee, compiling and delivering all files and records related to the prosecution or enforcement of the Patents and Trademarks and (ii) use commercially reasonable efforts to cause each of EchoStar Technologies International Corporation and DISH Network L.L.C. to permit Assignor to assign to Assignee its rights under that certain Patent License and Assignment Agreement, entered into as of September 22, 2017, by and among Assignor, EchoStar Technologies International Corporation and DISH Network L.L.C.. Assignor hereby constitutes and appoints Assignee the true and lawful attorney of Assignor to act as Assignor's attorney-in-fact solely for the purpose of executing any documents and taking all necessary steps to cause Assignor to perform any of Assignor's obligations set forth in this Assignment or the Purchase Agreement.

5. Recordation. Assignor authorizes and requests the U.S. Patent and Trademark Office and any foreign equivalent thereto, any applicable domain name registrar, and any other governmental or quasi-governmental body or authority to record Assignee, including any of its successors and designees, as owner of the Acquired Intellectual Property (including the Patents, Trademarks and Domain Names) and of the entire title and interest in, to and under the same, for

the use and enjoyment of the Acquired Intellectual Property (including the Patents, Trademarks and Domain Names) by Assignee, its successors, assigns and other legal representatives.

6. Purchase Agreement. This Agreement is delivered pursuant to the Purchase Agreement, and is subject to all of the representations, warranties, covenants and agreements set forth in the Purchase Agreement. In the event of any inconsistency between the terms of this Assignment and the terms of the Purchase Agreement, the terms of the Purchase Agreement shall govern and shall supersede this Assignment in all respects.

7. No Third Party Beneficiaries. Nothing in this Assignment, express or implied, is intended or shall be construed to confer upon, or give to, any person other than the Parties any remedy or claim under or by reason of this Assignment or any agreements, terms, covenants or conditions hereof, and all the agreements, terms, covenants and conditions in this Assignment shall be for the sole and exclusive benefit of the Parties and their respective successors and permitted assigns.

8. Binding Effect; Assignment. All of the covenants, terms and conditions set forth herein shall be binding upon and shall inure to the benefit of the Parties and their respective successors and assigns.

9. Governing Law. THIS ASSIGNMENT SHALL BE GOVERNED BY AND CONSTRUED IN ACCORDANCE WITH THE LAWS OF THE STATE OF DELAWARE (WITHOUT REGARD TO ANY APPLICABLE CONFLICTS OF LAW PRINCIPLES THEREOF).




