PATENT ASSIGNMENT


WHEREAS, on or about December 1, 2017, Zakariya Niazi ("Niazi"), an individual residing at 1 S Clinton Avenue, Apt 1802, Rochester NY 14604, entered into a Contribution and Assignment Agreement with Circle Optics, Inc., a corporation organized and existing under the laws of the State of Delaware USA, having a place of business at 260 East Main Street, Rochester, NY 14604 ("Circle Optics"), wherein Niazi assigned to Circle Optics all of his right, title, and interest in and to any Intellectual Property (as defined in that agreement) that existed as of December 1, 2017;

WHEREAS, Niazi is the inventor, applicant, and owner of all right, title, and interest in and to the United States and international patents and patent applications listed in the annexed **Exhibit A** (collectively referred to herein as the "Patents"), and Niazi and Circle Optics desire to formalize the assignment of the Patents to Circle Optics;

NOW, THEREFORE, for good and valuable consideration, the receipt of which is hereby acknowledged, Niazi has assigned, sold and transferred, and does assign, sell and transfer to Circle Optics, its successors and assigns, the entire right, title and interest in and to the Patents, and all provisional, divisional, reissue, continuation, continuation-in-part applications and extensions of any of the Patents, including all applications claiming the priority of said Patents, and the right to apply for patent in foreign countries with full benefit of such priorities as may now or hereafter be granted to Niazi by local laws or by treaty, including any international convention, for the protection of industrial property, together with the right to extend the protection of the United States Patent(s) to the various territorial possessions now owned or which may be hereafter acquired by the United States of America. Circle Optics will hold all rights for its own use and benefit and for the use and benefit of its successors or assigns to the full end of the term for which the Patents may be granted, as fully and entirely as the same would have been held and enjoyed by Niazi if this assignment and sale had not been made. Niazi requests and authorizes the Commissioner of the U.S. Patent and Trademark Office, and foreign counterpart officials of foreign patent offices, to issue respective Patents in the United States and foreign countries when granted, in accordance with this assignment.

Niazi further covenants and agrees with Circle Optics that Niazi has a full and unencumbered title to the Invention, which title Niazi warrants to Circle Optics. Niazi further agrees that he will, without demanding any further consideration therefor, at the request and expense of Circle Optics, do all lawful and just acts, including the execution and acknowledgment of instruments, that may be or become necessary for obtaining, sustaining, extending, reissuing, or reexamining the Patents, and for maintaining and perfecting Circle Optics' right to the Patents particularly in cases of interference conflict, opposition, and litigation.


