PATENT ASSIGNMENT AGREEMENT

THIS PATENT ASSIGNMENT AGREEMENT is entered into as of the Effective Date by and between:

- (1) Pronova UG (haftungbeschränkt), a limited liability company incorporated and registered under the laws of Germany, having its registered office at Goeppinger Straße 41/1 73614 Schorndorf, Germany ("**Assignor**"); and
- (2) Electrolux Appliances AB, a limited liability company incorporated and registered under the laws of Sweden, having its registered office at 105 45 Stockholm, Sweden ("**Electrolux**").

Assignor and Electrolux are hereinafter individually referred to as a "**Party**" and collectively as the "**Parties**".

WHEREAS

- (A) Assignor is the owner of the Patent Rights as defined herein.
- (B) Assignor desires to assign to Electrolux; and Electrolux desires to acquire from Assignor, all right, title and interest in and to the Patent Rights.
- (C) Following the assignment of the Patent Rights under this Agreement, Electrolux will hold the full ownership to the Patent Rights without restriction.

NOW, THEREFORE IT IS AGREED AS FOLLOWS:

1. DEFINITIONS AND INTERPRETATION

- 1.1 When used in this Agreement, the following capitalised terms shall have the following meanings, which shall be equally applicable to the singular and plural forms of such terms:

"**Agreement**" means this Patent Assignment Agreement and any and all schedules and appendices hereto;

"**Assignor**" has the meaning set out in the introduction of this Agreement;

"**Assignment Date**" means Effective Date.

"**Effective Date**" means the last date of signature.

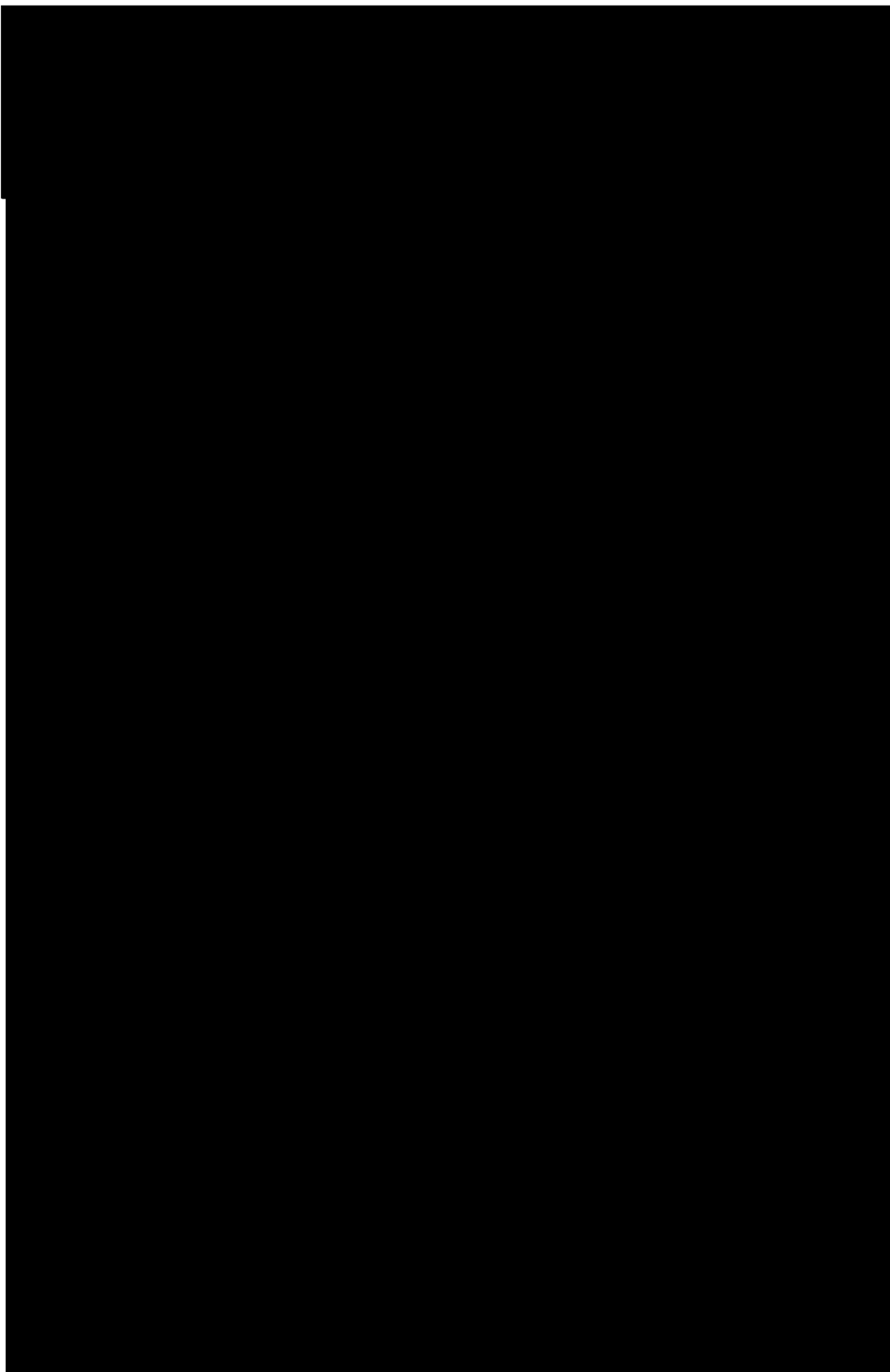
"**Party**" and "**Parties**" have the meanings set out in the introduction of this Agreement;

"**Patent Rights**" means the patents and patent applications anywhere in the world active on the Assignment Date which are listed in Schedule 1.

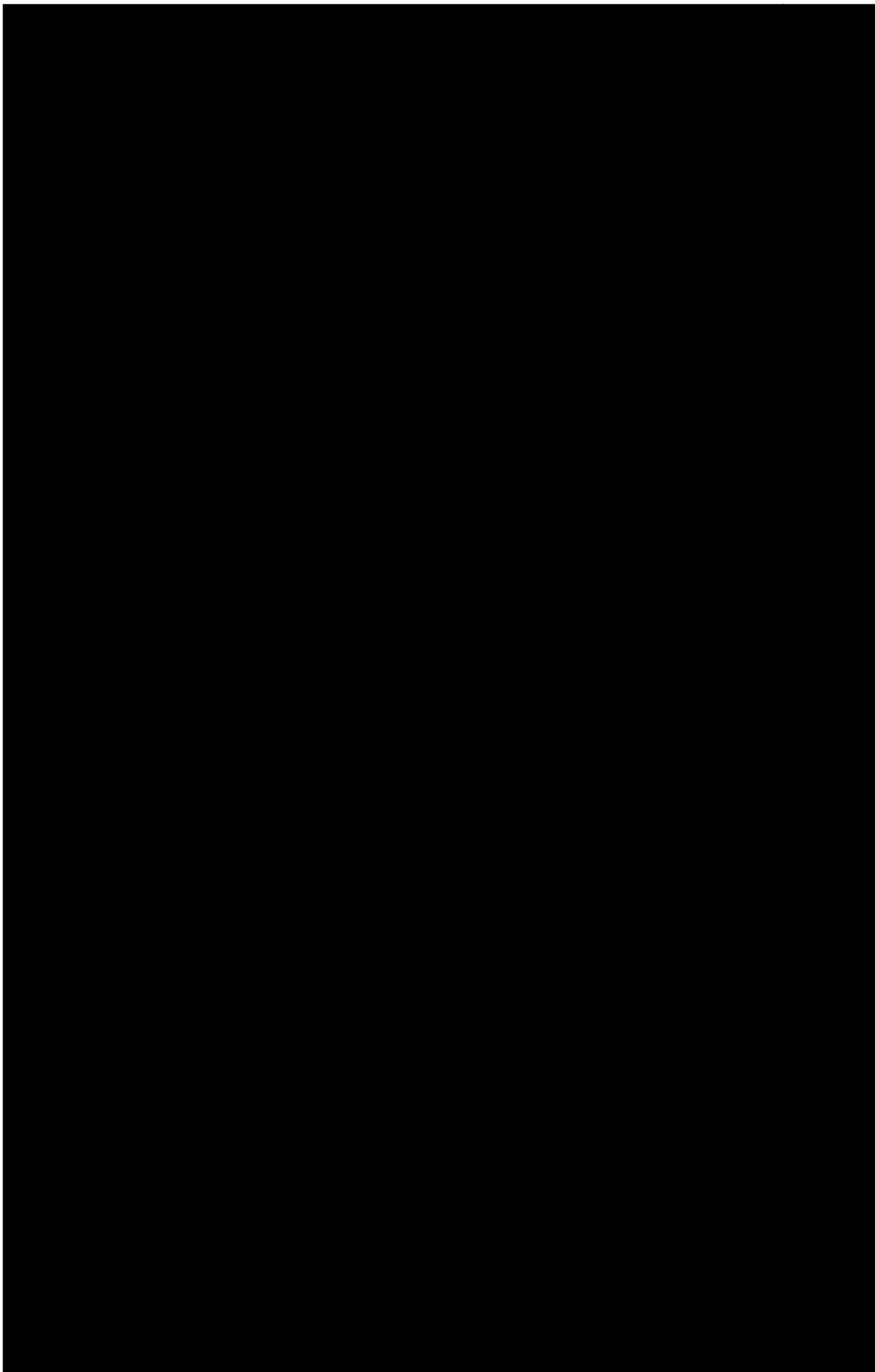
- 1.2 The headings in this Agreement are for convenience only and shall not affect the interpretation of any provision of this Agreement.

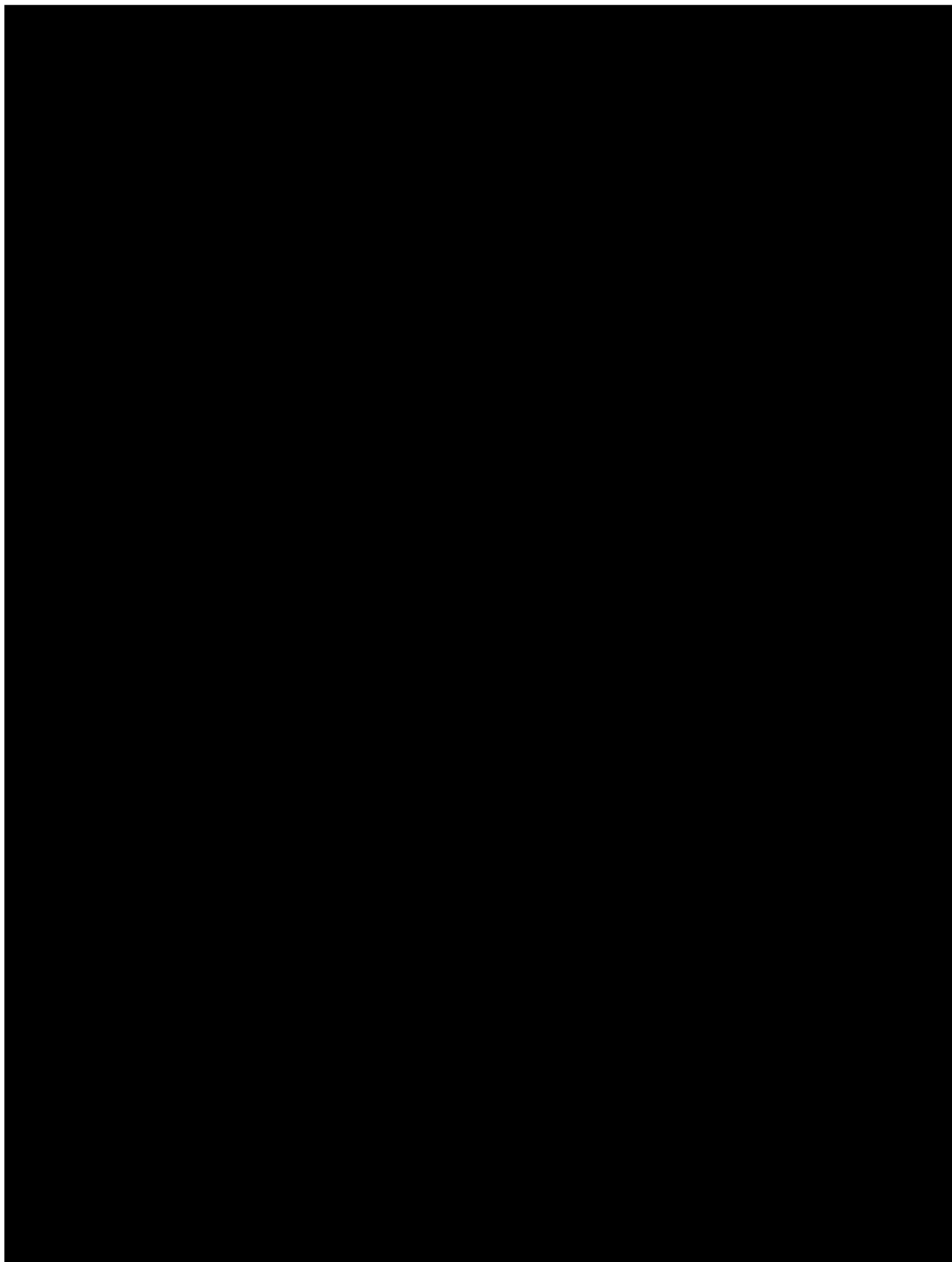
2. ASSIGNMENT






