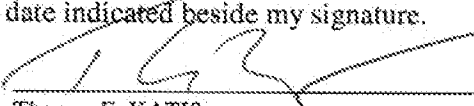
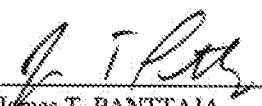
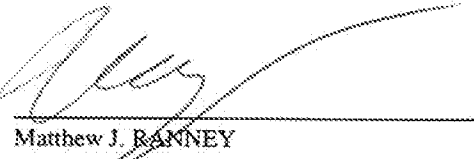
Whereas I, an undersigned inventor, have invented certain new and useful improvements as set forth in the following patent application:
