TERMINATION AND RELEASE OF SECURITY INTEREST IN PATENTS

This TERMINATION AND RELEASE OF SECURITY INTEREST IN PATENTS (this “Release”) dated as of January 26, 2023 (the “Release Date”), by JPMorgan Chase Bank, N.A. (as successor by merger to Bank One, N.A., in its capacity as collateral agent (the “Collateral Agent”)) for the benefit of Astec Industries, Inc., a Tennessee corporation (the “Grantor”).

WHEREAS, the Grantor has entered into that certain (i) Security Agreement, dated as of May 13, 2002, by and among the Grantor, the Collateral Agent and the other credit parties party thereto (the “Security Agreement”), and (ii) Borrower Patent Security Agreement, dated as of April 11, 2003, in favor of the Collateral Agent (the “Patent Security Agreement”);

WHEREAS, pursuant to the Patent Security Agreement and the Security Agreement, the Grantor pledged and granted to the Collateral Agent a first priority security interest in and to all of its right, title and interest in, to and under all of the Patent Collateral (including, without limitation, those referred to on Schedule I hereto);

WHEREAS, the Collateral Agent filed with the United States Patent and Trademark Office (the “USPTO”) notices of security interests in the Patent Collateral and the Patent Security Agreement which was recorded by the USPTO on May 2, 2003 at Reel 014027, Frame 0141;

WHEREAS, all liens granted to the Collateral Agent in connection with the Note Purchase Agreement and the Security Agreement on the assets of the Grantor have been released and the Grantor has requested that the Collateral Agent release its security interest in the Patent Collateral.

NOW THEREFORE, in consideration thereof and for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Collateral Agent agrees as follows:

1. Release of Security Interest. Effective as of the Release Date, the Collateral Agent hereby, without any representation and warranty and without any recourse (a) terminates the liens and security interests created under the Patent Security Agreement in the Patent Collateral, (b) releases its security interest in the Patent Collateral, (c) discharges any and all rights, title and interest it has in and the security interest granted to the Collateral Agent in the Patent Collateral, (d) terminates the Patent Security Agreement, and (e) reassigns, regrants and reconveys to the Grantor any and all of the Collateral Agent’s right, title and interest in and to the Patent Collateral.

2. Recordation of Release. The Collateral Agent understands and agrees that this Release shall be recorded by the Grantor or its representatives with the USPTO.

3. Capitalized Terms. Capitalized terms used herein and not otherwise defined shall have the meanings ascribed thereto in the Patent Security Agreement or the Security Agreement, as applicable.
