Release of Grant of Security Interest in Patent Rights

This Release of Grant of Security Interest in Patent Rights, dated as of February 1, 2023 (the “Release”), is made by Antares Capital LP, as collateral agent (in such capacity, the “Collateral Agent”) in favor of LB USA FLEXIBLES, INC. (formerly known as DAVID S. SMITH AMERICA INC.), a Delaware corporation, and LIQUI-BOX FLEXIBLES, INC. (formerly known as DSS RAPAK, INC.), a Delaware corporation (both a “Grantor” and collectively the “Grantors”).

WHEREAS, by (i) that certain Security Agreement, dated as of February 27, 2020, in favor of Collateral Agent (as amended, restated, or modified from time to time, the “Security Agreement”) and (ii) that certain related Grant of Security Interest in Patent Rights, dated as of February 27, 2020 in favor of Collateral Agent (as amended, restated, or modified from time to time, the “Patent Security Agreement”; capitalized terms used herein but not otherwise defined herein have the meanings given to them in the Security Agreement or Patent Security Agreement, as applicable), which Patent Security Agreement was recorded with the United States Patent and Trademark Office on February 29, 2020 at Reel 051971, Frame 0820, the Grantors granted to Collateral Agent, for the benefit of the Secured Parties, a lien on and security interest in all of the Grantors’ right, title and interest in, to and under the Collateral (as defined in the Patent Security Agreement), including those Patents listed on Schedule I hereto;

WHEREAS, the Grantors desire Collateral Agent to release, discharge, terminate and cancel its lien on and security interest in the Collateral, including, without limitation, the Patents set forth on Schedule I hereto;


NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, Collateral Agent, on behalf of the Secured Parties, does hereby release, discharge, terminate and cancel any and all of its right, title and interest in and to the Collateral and assigns, transfers and conveys to Grantors any and all of its rights, title and interests in the Collateral.

The Collateral Agent authorizes and requests that the Commissioner for Patents and any other applicable government officer record this Release.

This Release and the rights and obligations of the parties hereto shall be governed by, and construed and interpreted in accordance with, the laws of the State of New York.
