**CERTIFICATE OF AMENDMENT
TO THE
FIFTH AMENDED AND RESTATED CERTIFICATE OF INCORPORATION
OF
YUMANITY THERAPEUTICS, INC.
(a Delaware corporation)**

Yumanity Therapeutics, Inc. (the “*Company*”), a company organized and existing under and by virtue of the General Corporation Law of the State of Delaware (the “*DGCL*”), does hereby certify as follows:

1. The name of the corporation is Yumanity Therapeutics, Inc.
2. This Certificate of Amendment (the “*Certificate of Amendment*”) amends the provisions of the Company’s Fifth Amended and Restated Certificate of Incorporation filed with the Secretary of State on February 17, 2016, as amended (the “*Amended and Restated Certificate of Incorporation*”).
3. Article I of the Amended and Restated Certificate of Incorporation is hereby amended and restated to read in its entirety as follows:

“ARTICLE I

The name of the Corporation is Kineta, Inc.”

4. The foregoing amendment was duly adopted in accordance with the provisions of Section 242 of the DGCL.
