GRANT OF A SECURITY INTEREST – PATENTS

This Patent Security Agreement (this “Patent Security Agreement”) is made as of February 6, 2023, by OMNI ENERGY SERVICES CORP. (“Grantor”), in favor of WELLS FARGO BANK, NATIONAL ASSOCIATION, in its capacity as Agent for itself and the other members of the Lender Group (together with its successors in such capacity, “Grantee”). All capitalized terms used but not otherwise defined herein have the meanings given to them in the Security Agreement (as defined below).

WHEREAS, the Grantor is the record owner of the Patents listed on the attached Schedule A;

WHEREAS, the Grantor has entered into a Guaranty and Security Agreement, dated February 6, 2023 (as amended, restated, amended and restated, supplemented, modified or otherwise changed from time to time, the “Security Agreement”), among Grantor, certain of Grantor’s Affiliates listed on the signature pages thereto and Grantee; and

WHEREAS, pursuant to the Security Agreement, the Grantor has granted to the Grantee for the benefit of each member of the Lender Group, a continuing security interest in all right, title and interest of the Grantor in, to and under the Patents to secure the Secured Obligations.

NOW, THEREFORE, as collateral security for the payment, performance and observance of all of the Secured Obligations, the Grantor hereby pledges and collaterally assigns to Grantee, and grants to Grantee, for the benefit of each member of the Lender Group, a continuing security interest in the Patents.

The Grantor does hereby further acknowledge and affirm that the rights and remedies of the Grantee with respect to the Patents are more fully set forth in the Security Agreement, the terms and provisions of which are hereby incorporated herein by reference as if fully set forth herein.


