PATENT ASSIGNMENT

Assignor does hereby sell, assign, transfer, and convey to Assignee all of Assignor's right, title, and interest (i) in and to the Patent Rights in the United States and in all foreign countries; (ii) in and to any and all Letters Patent which may be granted therefrom in the United States and in any and all foreign countries; and (iii) in and to any and all divisions, reissues, continuations, continuations-in-part, and extensions thereof, including, in each case, the right to sue for past infringements and any other prior occurring rights, provided any such rights exist. Assignor further assigns to Assignee the right to claim entitlement and/or priority to any of the Patent Rights for which entitlement or priority may be claimed, including the assignment of any provisionals or other priority documents to which the Patent Rights claim priority. The assignment of the right to claim entitlement and/or priority is executed *nunc pro tunc* and is considered effective as of the filing date of the earliest application to which priority and/or entitlement is claimed. Assignor hereby authorizes and requests that said Letters Patent be issued in accordance with this assignment.

This Assignment shall inure to the benefit of and be binding upon the successors and permitted assigns of the parties hereto. This Assignment may be executed in one or more counterparts, each of which shall be deemed to be an original, but all of which taken together shall be one and the same instrument.

THIS ASSIGNMENT SHALL BE GOVERNED BY, AND SHALL BE CONSTRUED AND ENFORCED IN ACCORDANCE WITH, THE LAWS OF THE STATE OF NORTH CAROLINA, WITHOUT REGARDS TO CONFLICTS OF LAW PRINCIPLES.
