Whereas, Gary N. The United States Commissioner of Patents and Trademarks is hereby requested to issue any Letters Patent granted upon said Inventions set forth in said Applications to said Bluegrass Eye Surgery.

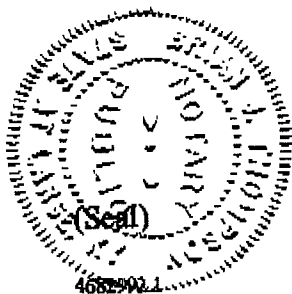
