conventions to the above-referenced patent application(s), all applications based in whole or in part upon the above-referenced patent application(s), including, without limitation, all applications that are a provisional, non-provisional, national phase application, regional phase application, design, divisional, continuation, continuation-in-part, registration, utility model, petty patent application, industrial design, reissue, renewal, substitute, extension that may be filed in the U.S. and/or any country or jurisdiction foreign to the U.S., the patents that may issue thereon, and the patents as may be modified as the result of applicable procedures, including, but not limited to, *ex parte* reexaminations, *inter partes* reexaminations, post-grant reviews, *inter partes* reviews, supplemental examinations, and oppositions;

 - (d) all claims for damages by reason of past infringement of any rights under the applications or patents described in (a), (b) or (c) of this paragraph (including provisional rights to reasonable royalties pursuant to 35 U.S.C. §154(d)) and the right to sue for and collect such damages and royalties for **ASSIGNEE**'s own use, including the same for **ASSIGNEE**'s legal representatives and assigns, as fully and entirely as the same would have been held by the **ASSIGNOR** had this assignment, transfer, and sale not been made.
