RELEASE OF SECURITY INTEREST

This Release of Security Interest is made as of February 15, 2023, by Montage Capital II, L.P. (“Lender”), in favor of FreightVerify, Inc., a Delaware corporation (“Company”), with its principal place of business located at 317 S. Main Street, Suite 400, Ann Arbor, MI 48104.

Recitals

NOW THEREFORE, Lender hereby agrees that the Security Agreement is terminated and Lender terminates and releases its security interest in the Intellectual Property and reassigns to Company, without warranty or recourse, all interest of Lender in the Intellectual Property.
