**INTELLECTUAL PROPERTY SECURITY AGREEMENT**

THIS INTELLECTUAL PROPERTY SECURITY AGREEMENT (this “*Agreement*”), is made as of January 31, 2023, by and among VOLTA INC., a Delaware corporation (“*Parent*”), VOLTA CHARGING, LLC, a Delaware limited liability company (“*Volta Charging*”), VOLTA MEDIA LLC, a Delaware limited liability company (“*Volta Media*”), VOLTA CHARGING SERVICES LLC, a Delaware limited liability company (“*Volta Services*”), VOLTA CHARGING INDUSTRIES, LLC, a Delaware limited liability company (“*Volta Industries*”), and together with Parent, Volta Charging, Volta Media, and Volta Services, collectively, the “*Initial Grantors*”, and each individually an “*Initial Grantor*”), and any additional persons or entities from time to time party hereto (such additional persons or entities, together with the Initial Grantors, each a “*Grantor*”, and collectively, the “*Grantors*”), for the benefit of EQUILON ENTERPRISES LLC D/B/A SHELL OIL PRODUCTS US, a Delaware limited liability company, as administrative agent and collateral agent (in such capacity, “*Agent*”) for itself and for the benefit of the lenders party the Loan Agreement (defined below).

**WITNESSETH:**

WHEREAS, the Initial Grantors, the other Credit Parties party thereto, the Agent, and the Lenders party thereto have entered into that certain Term Loan, Guarantee And Security Agreement dated as of January 17, 2023 (as it may be amended, restated, amended and restated, modified, supplemented, renewed or extended from time to time, the “*Loan Agreement*”; all capitalized terms used herein but not otherwise defined herein shall be used as defined in the Loan Agreement); and

WHEREAS, under the terms of the Loan Agreement, the Grantors have granted to the Agent, for the ratable benefit of the Lenders, a security interest in, among other property, certain intellectual property of the Grantors, and have agreed as a condition thereof to execute this Agreement for recording with the U.S. Patent and Trademark Office, the United States Copyright Office and other governmental authorities.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, each Grantor agrees as follows:

1. Grant of Security. Each Grantor hereby grants to the Agent for the ratable benefit of the Lenders a security interest in all of such Grantor’s right, title and interest in and to the following (the “*Collateral*”):

(a) the patents and patent applications set forth in Schedule A hereto (the “*Patents*”);

(b) the trademark and service mark registrations and applications set forth in Schedule B hereto (provided that no security interest shall be granted in United States intent-to-use trademark applications to the extent that, and solely during the period in which, the grant of a security interest therein would impair the validity or enforceability of such intent-to-use trademark applications under applicable federal law), together with the goodwill symbolized thereby (the “*Trademarks*”);

(c) all copyrights, whether registered or unregistered, now owned or hereafter acquired by such Grantor, including, without limitation, the copyright registrations, applications and recordings set forth in Schedule C hereto (the “*Copyrights*”);

(d) all reissues, divisions, continuations, continuations-in-part, extensions, renewals and reexaminations of any of the foregoing, all rights in the foregoing provided by international treaties or conventions, all rights corresponding thereto throughout the world and all other rights of any kind whatsoever of such Grantor accruing thereunder or pertaining thereto;

(e) any and all claims for damages and injunctive relief for past, present and future infringement, dilution, misappropriation, violation, misuse or breach with respect to any of the foregoing, with the right, but not the obligation, to sue for and collect, or otherwise recover, such damages; and

(f) any and all proceeds of, collateral for, income, royalties and other payments now or hereafter due and payable with respect to, and supporting obligations relating to, any and all of the Collateral of or arising from any of the foregoing.

2. Security for Obligations. The grant of a security interest in the Collateral by each Grantor under this Agreement secures the payment of all Obligations of such Grantor now or hereafter existing under or in respect of the Loan Documents, whether direct or indirect, absolute or contingent, and whether for principal, reimbursement obligations, interest, premiums, penalties, fees, indemnifications, contract causes of action, costs, expenses or otherwise. Without limiting the generality of the foregoing, this Agreement secures, as to each Grantor, the payment of all amounts that constitute part of the Obligations and that would be owed by such Grantor to any Lender under the Loan Documents but for the fact that such Obligations are unenforceable or not allowable due to the existence of a bankruptcy, reorganization or similar proceeding involving a Credit Party.

3. Recordation. Each Grantor authorizes and requests that the Register of Copyrights, the Commissioner for Patents and the Commissioner for Trademarks and any other applicable government officer record this Agreement.

4. Execution in Counterparts. This Agreement may be executed in any number of counterparts, each of which when so executed shall be deemed to be an original and all of which taken together shall constitute one and the same agreement. This Agreement may be authenticated by manual signature, facsimile, or, if approved in writing by Agent, electronic means, all of which shall be equally valid.

5. Grants, Rights and Remedies. This Agreement has been entered into in conjunction with the provisions of the Loan Agreement. This Agreement is subject in all respects to the terms and provisions of the Loan Agreement, including, but not limited to, each Grantor’s obligations, representations, warranties and covenants relating to the Collateral. Each Grantor acknowledges and agrees that the obligations, representations, warranties and covenants contained in the Loan Agreement shall not be superseded hereby but shall remain in effect to the extent provided therein. In the event of any conflict or inconsistency between the terms of the Loan Agreement and the terms hereof, the terms of the Loan Agreement shall govern.

6. Governing Law. This Agreement shall be governed by, and construed in accordance with, the laws of the State of New York, but giving effect to federal laws applicable to national banks.


