1. The name of the limited liability company is Baker Hughes, a GE company, LLC.

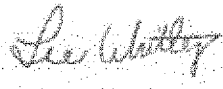
2. Article FIRST of the Company’s Certificate of Formation is hereby amended to read in its entirety as set forth below:
