RELEASE OF PATENT SECURITY INTEREST

This RELEASE OF PATENT SECURITY INTEREST ("Release") is effective as of February 14, 2023 and granted by KeyBank National Association, as collateral agent (the "Agent") for the lenders under the Credit Agreement referred to below (the "Secured Parties"), in favor of K & N ENGINEERING, INC., a California corporation (the "Grantor").

WHEREAS, pursuant to that certain Second Lien Credit Agreement, dated as of October 20, 2016 (as amended, restated, amended and restated, supplemented or otherwise modified from time to time, the "Credit Agreement"), by and among K&N Merger Sub II, Inc. ("Merger Sub"), and following the consummation of the Acquisition, K&N Parent, Inc., as borrower (the "Borrower"), K&N Intermediate Holdings II, Inc., as Guarantor (the "Parent"), the other Guarantors party thereto from time to time, the Agent, as Administrative Agent and Collateral Agent, and each lender from time to time party thereto (collectively, the "Lenders" and individually, a "Lender"), and that certain Second Lien Security Agreement, dated as of October 20, 2016 (as amended, restated, amended and restated, supplemented or otherwise modified from time to time, the "Security Agreement"), by and among the Borrower, the Parent, the Grantor, K&N Acquisition, Inc., and the Collateral Agent, the Grantor granted to the Agent, for the benefit of the Secured Parties, a security interest in, among other property, certain intellectual property of the Grantor, and executed and delivered to the Agent that certain Second Lien Patent Security Agreement, dated as of October 20, 2016, by and between the Grantor and the Agent (the "Patent Security Agreement") for recording with the United States Patent and Trademark Office (the "USPTO");

WHEREAS, the Patent Security Agreement was recorded with the USPTO on October 20, 2016, at Reel 040436, Frame 0534; and

WHEREAS, the Credit Agreement has been terminated and the Grantor has requested that the Agent enter into this Release in order to evidence the release and reassignment to the Grantor of any and all right, title and interest the Agent and the Secured Parties may have in the Collateral pursuant to the Patent Security Agreement;

NOW THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Agent agrees as follows:

- 1. <u>Defined Terms</u>. All capitalized terms used herein but not otherwise defined herein have the meanings given to them in the Credit Agreement, Security Agreement, or Patent Security Agreement, as applicable.
- 2. <u>Release of Security Interest</u>. The Agent, on behalf of itself and the Secured Parties, without recourse to or representation or warranty by the Agent of any kind, hereby terminates the Patent Security Agreement and terminates, releases and discharges any and all security interests that it has pursuant to the Patent Security Agreement in any and all right, title, and interest of the Grantor, and reassigns to the Grantor any and all right, title, and interest that it may have, in, to and under the following Collateral:

- (a) all issued patents and pending applications for patents of the Grantor (now owned or hereafter acquired) that constitute Collateral, including the patents and patent applications set forth in <u>Schedule 1</u> hereto;
- (b) income, fees, royalties, damages, claims and payments then or thereafter due and/or payable to the Grantor with respect to any of the foregoing, including damages and payments for past, present or future infringements thereof; and
 - (c) rights to sue for past, present or future infringements thereof.
- 3. <u>Governing Law</u>. This Release shall be governed by, and construed in accordance with, the laws of the State of New York.
