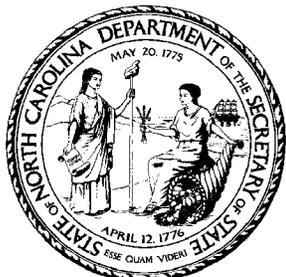

Pursuant to Title 8, Section 252 of the Delaware General Corporation Law, the undersigned corporation executed the following Certificate of Merger:

**FIRST:** The name of the surviving corporation is Vivet Inc., a Delaware corporation and the name of the corporation being merged into this surviving corporation is Schnadig International Corporation, a North Carolina corporation.
