## **ASSIGNMENT OF INVENTION AND PATENT RIGHTS**

WHEREAS, **Jeffrey A Whitsett**, a citizen of The United States of America, residing at 5565 Salem Road, Cincinnati, OH, 45230; and **Yutaka Maeda**, a citizen of Japan, residing at 2495 Spindlehill Drive, Unit #3, Cincinnati, OH, 45230; (hereinafter referred to collectively as "ASSIGNOR"), have invented **Role of midkine inhibitors in malignant pleural mesothelioma**, for which an application for Letters Patent of the United States has been filed as, Serial No. **62/367,832**, filed on **7/28/2016**; and

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, ASSIGNOR hereby sells, assigns, and transfers and sets over, unto the said ASSIGNEE, its successors, legal representatives and assigns, the entire right, title and interest in, to and under the said invention, and the said United States application and all divisions, renewals, and continuations thereof, and all patents of the United States which may be granted thereon and all reissues, reexaminations and extensions thereof; and all Patents of the United States which may be granted thereon and all applications for industrial property protection, including, without limitation, all applications for patents, utility models, and designs which may hereafter be filed for said invention in any country or countries foreign to the United States, together with the right to file such applications and the right to claim for the same the priority rights derived from said United States application under Patent Laws of the United States, the International Convention for the Protection of Industrial Property, or any other international agreement or the domestic laws of the country in which any such application is filed, as may be applicable; and all forms of industrial property protection, including, without limitation, patents, utility models and designs, which may be granted for said invention in any country or countries foreign to the United States and all extensions, renewals, reexaminations and reissues thereof;

ASSIGNOR HEREBY authorizes and requests the Commissioner of Patents and Trademarks of the United States, and any Official of any country or countries foreign to the United States, whose duty it is to issue patents or other evidence or forms of industrial property protection on applications as aforesaid, to issue the same to the said ASSIGNEE, its successors, legal representatives and assigns, in accordance with the terms of this instrument.

ASSIGNOR HEREBY grants the ASSIGNEE, its successors, legal representatives and assigns, the power to insert in this Assignment any further identification or information which may be necessary or desirable in order to comply with the rules of the United States Patent and Trademark Office for recordation of this document.

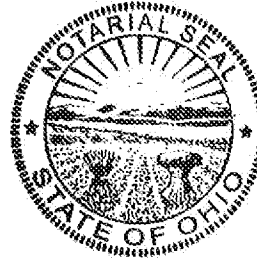
