**Patent Assignment and Bill of Sale**

Dated February 23, 2023

WHEREAS, Lyncean (Assignment for the Benefit of Creditors), LLC, a California limited liability company, in its sole and limited capacity as assignee for the benefit of creditors of Lyncean Technologies, Inc. ("Assignor") is the owner of the Patents (as defined below);

WHEREAS, pursuant to the terms of that certain Asset Purchase Agreement, dated as of November 12, 2022 (the "Purchase Agreement"), by and among Assignor and Lyra Acquisition Holdings LLC, a limited liability company ("Assignee"), Assignor has agreed to assign to Assignee all of Assignor's right, title, and interest in and to the intellectual property previously held by Lyncean Technologies, Inc., and subject to that certain general assignment by and between Lyncean Technologies, Inc. and Lyncean (assignment for the benefit of creditors), LLC, including, for the avoidance of doubt, the patents and patent applications contained in the Initial Assignment (as defined below) and the Patents;

WHEREAS, in connection with that certain Purchase Agreement, Assignor has assigned certain patents and patent applications to the Assignee under that certain patent assignment (the "Initial Assignment"), but did not assign the Patents, and the Assignor and Assignee each of the Assignor and Assignee intended for the Patents to be assigned under the Initial Assignment; and

WHEREAS, the Assignor and Assignee desire that Assignor assigns the Patents to Assignee, and hereby confirm the terms and conditions of the Purchase Agreement, pursuant to this assignment (this "Patent Assignment and Bill of Sale").

NOW, THEREFORE, for the consideration set forth in the Purchase Agreement and other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the parties agree as follows:

1. Assignor hereby irrevocably sells, assigns and transfers to Assignee, Assignor's entire right, title and interest in and to each of the patents and patent applications described in Table 1 below (the "Patents"), including all continuations, divisions, continuations-in-part, requests for continued examination, reissues, reexaminations and extensions thereof; any other filings claiming priority to or serving as a basis for priority thereof; all patents issuing from any of the foregoing; the right to file foreign applications directly in the name of Assignee with respect to the inventions, discoveries or designs described in any of the Patents; the right to claim priority to any of the Patents or any of the inventions, discoveries and designs described in the Patents; and all causes of action and other enforcement rights under, or on account of, any of the foregoing for past, current or future infringement.




