## **PLAN OF CONVERSION OF SCIFI INDUSTRIAL LLC**

This Plan of Conversion ("Plan"), adopted pursuant to the California Revised Uniform Limited Liability Company Act, provides for the conversion (the "Conversion") of SCIFI INDUSTRIAL LLC, a California limited liability company into SCIFI INDUSTRIAL LTD, a California corporation (individually and collectively the "Company").

1. The name and type of the business entity prior to the Conversion is: SCIFI INDUSTRIAL LLC, a California limited liability company.

2. The name and type of the business entity after the Conversion is: SCIFI INDUSTRIAL LTD, a California corporation.

3. Pursuant to California Revised Uniform Limited Liability Company Act Section 17710.04, the Conversion shall become effective on the date set forth in this Plan of Conversion and such date shall be January 1, 2023 (the "Effective Date").

4. Upon the Effective Date, the sole member of the Company will continue to own all of the outstanding equity interests in the corporate shares of the converted Company.

5. On the Effective Date, the Company will file Articles of Incorporation and a Statement of Conversion with the California Secretary of State, which will remain the Company's Articles of Incorporation until altered, amended or repealed. The Company and its sole member will execute Bylaws effective as of the Effective Date. The Company will make an S corporation election after the Conversion.

6. On the Effective Date, the Company will continue to hold all of the rights and property of the Company as it held prior to the Conversion (specifically including, but not limited to, its patents and trademarks), and shall be subject to all of the debts and liabilities of the Company as it was subject prior to the Conversion. All rights of creditors and all liens upon the property of the Company (if any) will remain in effect upon the Conversion. Any action or proceeding pending by or against the Company prior to the Conversion will continue to bind the Company after the Conversion.

7. This Plan shall not be altered or otherwise amended except pursuant to an instrument in writing.

8. Except as otherwise specifically provided herein, nothing expressed or implied in this Plan is intended, or shall be construed, to confer upon or give any person, firm or company, other than the Company and its shareholder, any rights or remedies under or by reason of this Plan except as allowed by applicable law.



3. **Franchise Tax Board (FTB) Tax Filing** – Once your entity is registered with the SOS, you are required to file a tax return with FTB for each taxable year, even if you are not conducting business or have no income. Contact FTB at [www.ftb.ca.gov](http://www.ftb.ca.gov) or (800) 852-5711 for forms and requirements concerning franchise taxes or income taxes.

Be aware, if you fail to file a return by the original or extended due date, or fail to pay taxes when due, a penalty may be imposed by FTB. Please visit [www.ftb.ca.gov/businesses/Penalty-Information.shtml](http://www.ftb.ca.gov/businesses/Penalty-Information.shtml) for tax penalty related information.

#### 4. **Business Names and Trademarks**

Registration of a business with the Secretary of State does not in itself establish a trademark for the business name. There is a separate legal process to establish a trademark or service mark. Additionally, registration of a business with the Secretary of State does not authorize the use of a business name in violation of another person's or entity's rights to the name, such as infringement of a trademarked word or phrase.
