Patent Purchase Agreement - Exhibit A - Patent Assignment Agreement

This Patent Assignment Agreement is entered into and is effective as of September 15, 2022 ("**Effective Date**") by and between VideoLabs, Inc., a Delaware corporation and all of its Subsidiaries (collectively "**Assignee**") and Acer Inc., a Taiwan corporation ("**Assignor**") (collectively, the "**Parties**," and each a "**Party**").

For good and valuable consideration, Assignee and Assignor agree as follows.

1. Recitals

- 1.1. Assignor is the owner of the Patents (defined below).
- 1.2. Assignor and Assignee have agreed, by way of a purchase agreement (the "**Purchase Agreement**"), that Assignor will assign the Patents to Assignee. The terms of the Purchase Agreement are incorporated herein by reference and shall prevail in any conflict with the terms of this agreement.

2. Assignment

- 2.1. "**Patents**" means the patents and applications listed in Exhibit B - Patent List, and (except as noted in Exhibit B - Patent List):
 - 2.1(a) all patents and applications to which any of the patents and applications listed in Exhibit B - Patent List are entitled to claim priority; and
 - 2.1(b) all patents and applications that are entitled to claim priority to, or correspond to, any of the foregoing, including without limitation any and all continuations, continuing prosecution applications, divisions, extensions, provisionals, reissues, reexaminations, and counterparts of any of the foregoing in any jurisdiction.
- 2.2. Assignor hereby assigns and transfers to Assignee all right, title, and interest in the Patents, including without limitation all rights to collect damages, license payments, or royalties, enforce, license, pursue causes of action or remedies, pursue injunctive relief, and sue relating to any past, present, and / or future infringement of the Patents.
- 2.3. Assignee hereby accepts this assignment.

3. Assignment is Effective for Any Purpose

- 3.1. Assignor hereby consents that this Patent Assignment Agreement shall be deemed a full legal and formal equivalent of any assignment, consent to file, or similar document that may be required in any country for any purpose, including without limitation:
 - 3.1(a) recording this assignment in any patent office, including without limitation the United States Patent and Trademark Office, the European Patent Office, and any national patent office;


- 3.1(b) making any priority claim in a patent application under the International Convention for the Protection of Industrial Property or any other domestic or international law, agreement, or convention.
- 3.2. Assignor authorizes and empowers Assignee and its successors, assigns, legal representatives, and nominees to invoke and claim all rights assigned hereunder without further written or oral authorization from Assignor.
- 3.3. Assignor agrees that, whenever reasonably requested by Assignee, Assignor will, and if Assignor is unable or unwilling to do so authorizes Assignee to act in Assignor's name to execute all papers, take all rightful oaths, and do all acts that are reasonably necessary for securing and maintaining the Patents in any country, and for vesting and recording title in the Patents in Assignee, its successors, and assigns. Assignor hereby irrevocably appoints Assignee and its duly authorized agents as Assignor's attorney-in-fact, to act for and in Assignor's behalf with respect to the foregoing solely in case Assignor is unable or unwilling to perform the obligations set forth in this Section 3.3.


