- (c) any and all Letters Patent that may be granted for the Patent Applications in any and all countries and jurisdictions, including without limitation any renewals, reissues, re-examinations, and/or extensions thereof (collectively, the “Letters Patent”); and
- (d) the exclusive right to bring or participate in any proceeding for past, present or future infringement or any other actionable right under any or all of the foregoing and to receive all remedies that arise therefrom, to the end of the term for which the Letters Patent may be granted, as fully and entirely as the same would have been held by ASSIGNORS had this Assignment not been made;


