ASSIGNMENT OF PATENT RIGHTS

Parties

- (1) Rapid Action Packaging Limited a company incorporated and registered the UK whose principal place of business is at Mansel Court, 2A Mansel Road, Wimbledon, London, SW19 4AA (**Assignor**)
- (2) ProAmpac Holdings Inc., a company incorporated in Delaware, USA whose principal place of business is at 12025 Tricon Road, Cincinnati, Ohio 45246 (**Assignee**)

BACKGROUND

- A. The Assignor is the registered proprietor of, and/or applicant for, the patent rights as set out in Schedule 1 (the **Patents**).
- B. Pursuant to an agreement between the Assignor and the Assignee (the **Main Agreement**) the Assignor has agreed to assign to the Assignee all of the Assignor's right, title and interest in the Patents and other Assigned Rights (as defined in clause 2 below). To the extent that the Assignor's rights in the Patents and the invention(s) the subject thereof have not, whether by operation of law, contract or otherwise, effectively vested in the Assignee, the Assignor now agrees to assign all of their right, title and ownership interest in the Assigned Rights (as defined in clause 2 below) to the Assignee.

OPERATIVE PROVISIONS

1. Interpretation

The following definitions and rules of interpretation apply in this Assignment (which includes the Background).

- 1.1 A person includes a natural person, corporate or unincorporated body (whether or not having separate legal personality).
- 1.2 Unless the context otherwise requires, words in the singular shall include the plural and in the plural shall include the singular.
- 1.3 Unless the context otherwise requires, a reference to one gender shall include a reference to the other genders.
- 1.4 Any words following the terms **including, include, in particular, for example** or any similar expression shall be construed as illustrative and shall not limit the sense of the words, description, definition, phrase or term preceding those terms.

2. Assignment

Pursuant to and for the consideration set out in the Main Agreement and in consideration of the sum of £1 (one pound sterling) (receipt of which the Assignor expressly acknowledges) the Assignor now assigns and transfers to the Assignee absolutely all their right, title and interest in and to the Patents, including:

- (a) in and to all and any inventions disclosed in the Patents;
- (b) the right to claim priority from the Patents and to prosecute and obtain grant of patent;
- (c) the right to file divisional, continuations, continuations in part, reissues and extension applications based on the Patents and to prosecute, obtain grant of and own absolutely and exclusively patents on each and any such application;
- (d) in respect of each invention disclosed in the Patents, the right to file an application, claim priority from such application, and prosecute and obtain grant of patent, utility model or other intellectual property protection in or in respect of any country or territory in the world;
- (e) the right to extend or register in or in respect of any country or territory in the world the Patents, and each and any of the applications filed as mentioned above, and to extend to or register in, or in respect of, any country or territory in the world any patent, utility model or like protection granted on any of such applications;
- (f) the absolute entitlement to any patents granted pursuant to the Patents or any other applications filed as mentioned above; and
- (g) all rights, power and entitlements arising or accruing to any of the rights, property and interest assigned by this Assignment including the right to bring, make, oppose, defend, appeal proceedings, claims or actions and obtain relief (and to retain any damages recovered) in respect of any infringement, or any other cause of action arising from ownership, of the Patents or any patents granted pursuant to the Patents or any other applications filed as mentioned above, whether occurring before, on or after the date of this Assignment

collectively the **Assigned Rights**.

3. Counterparts

- 3.1 This Assignment may be executed in any number of counterparts, each of which shall constitute a duplicate original, but all the counterparts shall together constitute the one agreement.
- 3.2 Transmission of the executed signature page of a counterpart of this Assignment by email (in PDF, JPEG or other agreed format) shall take effect as the transmission of an executed "wet-ink" counterpart of this Assignment. If this method of transmission is adopted, without prejudice to the validity of the agreement thus made, each party shall on request provide the other[s] with the "wet-ink" hard copy original[s] of their counterpart.

4. Governing law and Jurisdiction

This Assignment and any dispute or claim (including non-contractual disputes or claims) arising out of or in connection with it or its subject matter or formation (a **Dispute**) shall be governed by and construed in accordance with the law of England and Wales. Each party irrevocably agrees that the courts of England and Wales shall have exclusive jurisdiction to settle any Dispute.




