## CONFIRMATORY PATENT ASSIGNMENT

**DATED:** 23rd day of February 2023

**PARTIES:** (1) A.T.KEARNEY LIMITED (company registration number 00944763) of Lansdowne House, Berkeley Square, London, W1J 6ER (the 'Assignor');

and

(2) EV8 TECHNOLOGIES LIMITED (formerly DATACO SOLUTIONS LIMITED) (company registration number 11175382) of Lansdowne House, Berkeley Square, London, W1J 6ER (the 'Assignee')

### **WHEREAS:**

- (A) The Assignor is the registered owner of certain patents and patent applications listed in the attached Schedule A (the 'Patent Rights')
- (B) By virtue of an agreement dated 7 February 2018 (the 'Main Agreement'), the Assignor assigned all its right, title and interest in the Patent Rights to the Assignor
- (C) The Assignee changed its legal name on 22 May 2018 from Dataco Solutions Limited to EV8 Technologies Limited
- (D) The Parties now wish to record the assignment of the Patent Rights and have executed this confirmatory patent assignment for recording at the intellectual property office in each jurisdiction

### **OPERATIVE PROVISIONS**

In accordance with the Main Agreement and for the consideration set out therein, the Assignor hereby confirms that, with effect from 7 February 2018, it sells, transfers, conveys, assigns and delivers to the Assignee and the Assignee accepts all the right, title and interest of the Assignor in and to:

- (a) the Patent Rights including any patents granted pursuant to any of the patent applications listed in attached Schedule A
- (b) all inventions and improvements described and claimed therein and any patents which may be granted from any divisional applications, re-issues, substitutions, continuations, continuations-in-part, re-examinations, foreign counterparts and extensions thereof

(c) all income, royalties, damages, claims and payments now or hereafter due or payable under and with respect thereto, including, without limitation, damages, claims and payments for past, present and future infringements of the Patent Rights

(d) all rights to sue for past, present and future infringements of the Patent Rights, including the right to settle suits involving claims and demands for royalties owing

(e) all rights corresponding to any of the foregoing throughout the world; and

(f) the right to assign the rights conveyed by virtue of the Main Agreement, the same to be held and enjoyed by the Assignee for its own use and benefit, and for the benefit of its successors, assigns and legal representatives


