CONFIRMATORY ASSIGNMENT

This Confirmatory Assignment Agreement ("Assignment") is made and entered into by and between Redx Pharma plc ("Redx Pharma"), a corporation formed under the laws of the United Kingdom and having a principal place of business at Block 33, Mereside, Alderley Park, Macclesfield SK10 4TG, United Kingdom and Redx Oncology Ltd. ("Redx Oncology"), a corporation formed under the laws of the United Kingdom and having a principal place of business at Block 33, Mereside, Alderley Park, Macclesfield, SK10 4TG, United Kingdom (Redx Pharma and Redx Oncology collectively referred to herein as "Assignors"), on the one hand, and Loxo Oncology, Inc. ("Assignee"), an Indiana, USA, corporation, having its principal place of business at Lilly Corporate Center, Indianapolis, IN 46285 and a correspondence address of c/o Eli Lilly and Company, P.O. Box 6288, Indianapolis, IN 46206-6288, and which is a wholly-owned subsidiary of Eli Lilly and Company, an Indiana, U.S., corporation having its principal place of business at Lilly Corporate Center, Indianapolis, IN 46285, on the other hand.

WHEREAS Nicolas E.S. Guisot ("Guisot") was at all relevant times an employee of the Assignors, having the job title BTK Project Leader at the relevant time;

WHEREAS, Guisot is an inventor of the patents and patent applications listed in Schedule A ("Schedule A Patents") and is an inventor of the inventions and improvements which are the subject of the Schedule A Patents (collectively, the "Inventions");

WHEREAS, pursuant to section 39(1) of the Patents Act 1977 in force at all relevant times in the United Kingdom, the Inventions, and any right, title and interest of Guisot in those Inventions, are taken to belong to the Assignor (the "Assigned Rights", (as defined below) as confirmed in the confirmatory assignment dated 19 July 2018;

WHEREAS, on July 29, 2017, Assignors and Assignee entered into an Assignment ("2017 Assignment") pursuant to which Assignors assigned to Assignee all of their right, title, and interest throughout the world in and to the Assigned Rights (as defined below);

WHEREAS, Assignee now wishes to confirm it has secured from Assignors their entire right, title, and interest throughout the world in and to the Assigned Rights (as defined below).

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged by all parties, the parties confirm as follows:

- I. For purposes of this Confirmatory Assignment, the following terms have the following meanings:

(a) The "Patents" means (i) the Schedule A Patents; (ii) any and all patents, patent applications, utility models and certificates of inventions filed or issued worldwide from which any of the Schedule A Patents claim priority; (iii) any and all patents, patent applications, utility models, and certificates of invention filed or issued worldwide claiming priority to any of the patents, patent applications, utility models, and certificates of invention in (i)-(ii) including all continuations, continuations-in-part, and divisionals; (iv) all reissues, reexaminations, extensions (including patent term extensions and patent term adjustments), and supplementary protection certificates of any of the patents, patent applications, utility models, and certificates of invention in (i)-(iii) and any patents resulting from any post-grant proceedings involving any of the patents, patent applications, utility models, and certificates of invention in (i)-(iii) including any *inter partes* review, any post-grant review, and any oppositions; and (v) any other patents, patent applications, utility models, and certificates of invention filed or issued worldwide claiming any inventions disclosed in the Schedule A Patents.

(b) The "Assigned Rights" means (i) the Patents; (ii) the inventions disclosed in the Patents; (iii) the right to file, prosecute, maintain, and defend the Patents, in its own name wherever so permitted by law or in the name of Assignors wherever necessary; (iv) the right to claim priority to any of the Patents pursuant to the Paris Convention for the Protection of Industrial Property, the Patent Cooperation Treaty, the European Patent Convention, and all other treaties of like purposes; and (v) the right to sue and collect damages and any other relief for any past, present, and future infringement of the Patents.

2. Each Assignor hereby confirms it assigned to Assignee all of its right, title, and interest throughout the world in and to the Assigned Rights. Each Assignor hereby confirms it has sold, assigned, transferred, and set over, unto Assignee, its lawful successors and assigns, all of Assignor's right, title, and interest throughout the world in and to the Assigned Rights. For the further avoidance of doubt, each Assignor hereby confirms it assigned to Assignee all of Assignor's right, title, and interest in and to any claims, whether known or unknown, suspected or unsuspected, of any nature, that each Assignor has or may have against any party for any past, present, or future infringement of the Patents.

3. Each Assignor shall, when requested by Assignee and at no cost to each Assignor, (i) execute or cause to be executed all rightful oaths, assignments, and all other papers necessary and proper to carry out the intent and purpose of the Assignment and this Confirmatory Assignment, (ii) execute all papers necessary in connection with the Assigned Rights and execute any separate assignment in connection with any of the Assigned Rights as Assignee may deem necessary or expedient; and (iii) perform all affirmative acts that may be necessary to obtain a grant of a valid patent to Assignee on any of the Inventions including as may be necessary to record the assignment of the Patents in the records of all relevant intellectual property registries. Each Assignor hereby appoints Assignee to be its attorney in its name and on its behalf to execute documents, use each Assignor's name and do all things which are necessary or desirable

for Assignee to obtain for itself or its nominee the full benefit of the Assignment and this Confirmatory Assignment in relation to the Assigned Rights. This power of attorney is irrevocable and is given by way of security to secure the performance of each Assignor's obligations under this clause and the proprietary interest of Assignee in the Assigned Rights and so long as such obligations of each Assignor remain undischarged, or Assignee has such interest, the power may not be revoked by either Assignor, save with the consent of Assignee.

5. This Confirmatory Assignment is binding upon and inures to the benefit of the successors and permitted assigns of the parties.
6. This Confirmatory Assignment and any dispute or claim (including non-contractual disputes or claims) arising out of or in connection with it or its subject matter or formation shall be governed by and construed in accordance with the laws of England and Wales.
7. Each party irrevocably agrees that the courts of England and Wales shall have exclusive jurisdiction to settle any dispute or claim (including non-contractual disputes or claims) arising out of or in connection with this Confirmatory Assignment or its subject matter or formation.
