## CONFIRMATORY PATENT ASSIGNMENT

THIS **CONFIRMATORY PATENT ASSIGNMENT** (the “Assignment”), is made effective as of January 1, 2023 (the “Effective Date”) among RADIENZ LIVING, LLC, a Delaware limited liability company having an address at 360 Moreland Road, Commack, NY 11725 (“RL Assignor”) and RADIENZ LIVING CHICAGO, LLC, a Delaware limited liability company having an address at 1804 W. Central Rd., Mt. Prospect, IL 60056 (“RLC Assignor”) and, together with RL Assignor, each an “Assignor” and collectively, the “Assignors”) and NEW SPS POD, LLC, a Delaware limited liability company having an address at 1804 W. Central Rd., Mt. Prospect, IL 60056 (“Assignee”).

**WHEREAS**, in connection with that certain Assignment and Assumption Agreement dated as of January 1, 2023, between, among others, Assignors and Assignee (the “Assignment Agreement”), each Assignor assigned to Assignee all of each Assignor’s right, title and interest in and to the patents and patent applications listed on the attached Exhibit A (“Patents”), including the right to sue for, recover damages and relief for, settle, or release any past, present or future infringement or misappropriation of the foregoing;

**WHEREAS**, Assignee desires to obtain, and each Assignor has agreed to provide this Assignment for purposes of recordation by the United States Patent and Trademark Office and corresponding offices in other countries.

**NOW, THEREFORE**, for one dollar (\$1) and other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Assignors and Assignee do hereby agree as follows:

1. Assignment. Each Assignor hereby sells, assigns, transfers and conveys to Assignee, its successors, assigns and legal representatives, all of its right, title and interest throughout the world in perpetuity in and to the Patents and the right to sue for, recover damages and relief for, settle, or release any past, present and future infringements and misappropriations thereof.

2. Assistance. Upon request of Assignee, each Assignor shall execute any and all powers of attorney, applications, assignments, declarations, affidavits, and any other papers in connection with all files and records reasonably necessary to perfect the rights, title and interest in Assignee, its successors, assigns and legal representatives in the Patents.

3. Governing Laws. This Assignment, the rights and obligations of the parties under this Assignment, and any claim or controversy directly or indirectly based upon, arising out of or related to, this Assignment or the transactions contemplated by this Assignment (whether based upon contract, tort or any other theory), including all matters of construction, validity and performance, shall be governed by and construed in accordance with the laws of the State of New York, without regard to the principles of conflicts of law that would provide for the application of another law.

4. Binding. This Assignment shall be binding upon and inure to the benefit of the parties and their respective successors and permitted assigns.

5. Counterparts. This Assignment may be executed in two or more counterparts, each of which shall be deemed an original and all of which, when taken together, will be deemed to constitute one and the same agreement. In the event that any signature to this Assignment is delivered by facsimile transmission or by e-mail delivery of a portable document format (.pdf or similar format) data file, such signature shall create a valid and binding obligation of the party executing (or on whose behalf such signature is executed) with the same force and effect as if such facsimile or “.pdf” signature page were an original thereof.




