AND, Assignor hereby irrevocably appoints Assignee, with full power of substitution, as Assignor's true and lawful attorney-in-fact in Assignor's name, place and stead to make, execute, assign, record and file, on Assignor's behalf and for the benefit of Assignee, such documents confirming Assignee's ownership and/or license rights that may be necessary or useful in Assignee's discretion. This Power of Attorney includes, but is not limited to, applying for, securing, maintaining, reissuing, extending, or defending Assignee's worldwide rights in the invention in any country worldwide, so as to secure to Assignee the full benefits of the invention


