RELEASE OF SECURITY INTEREST IN PATENTS INTELLECTUAL PROPERTY

This RELEASE OF SECURITY INTEREST IN PATENTS INTELLECTUAL PROPERTY (this “Release”), dated as of March 8, 2023 (the “Effective Date”), is made by WILMINGTON TRUST, NATIONAL ASSOCIATION, in its capacity as Collateral Agent for the benefit of the Secured Parties (the “Agent”), in favor of each grantor party identified on the signature page hereto (each a “Grantor” and together, the “Grantors”).

WHEREAS, pursuant to that certain Amended Second Lien U.S. Security Agreement, dated as of September 23, 2014 (as amended as of February 24, 2021, and as further amended, restated, amended and restated, supplemented or otherwise modified from time to time, the “Security Agreement”), by and among the Agent, the Grantors party thereto and certain other parties thereto, each Grantor party thereto granted to the Agent, in its capacity as collateral agent for the benefit of the Secured Parties, a security interest in, and lien on, certain collateral;

WHEREAS, pursuant to that certain Second Lien Grant of Security Interest in Patent Rights, dated as of September 23, 2014 (the “Original Patent Security Agreement”), made by AKI, Inc. in favor of Credit Suisse AG, Cayman Islands Branch (the “Retired Agent”), which was recorded with the United States Patent and Trademark Office on October 3, 2014 at Reel/ Frame No. 033888/0504, AKI, Inc. granted to the Retired Agent a continuing security interest in, and lien on, all of AKI, Inc.’s right, title and interest in, to and under certain United States Patent registrations and applications, including the right to receive all Proceeds therefrom;

WHEREAS, pursuant to that certain Assignment of Patent Security Agreement, dated as of February 24, 2021 (the “Assignment of Patent Security Agreement”), by and between the Retired Agent and the Agent, which was recorded with the United States Patent and Trademark Office on March 1, 2021 at Reel/Frame No. 055450/0950, the Retired Agent assigned to the Agent all of its rights, remedies, duties and other obligations under, among other documents, the Original Patent Security Agreement;

WHEREAS, pursuant to that certain Grant of Security Interest in Patent Rights, dated as of February 24, 2021 (the “Patent Security Agreement”), made by certain Grantors in favor of the Agent, which was recorded with the United States Patent and Trademark Office on March 1, 2021 at Reel/Frame No. 055446/0447, each Grantor party thereto granted to the Agent a continuing security interest in, and lien on, all of such Grantor’s right, title and interest in, to and under certain United States Patent registrations and applications, including the right to receive all Proceeds therefrom; and

WHEREAS, , pursuant to that certain Grant of Security Interest in Patent Rights, dated as of May 25, 2021 (collectively with the Original Patent Security Agreement, the Assignment of Patent Security Agreement and the Patent Security Agreement, the “Patent Security Agreements”), made by certain Grantors party thereto in favor of the Agent, which was recorded with the United States Patent and Trademark Office on June 1, 2021 at Reel/Frame No. 056399/0072, each Grantor party thereto granted to the Agent a continuing security interest in, and lien on, all of such Grantor’s right, title and interest in, to and under certain United States Patent registrations and applications, including the right to receive all Proceeds therefrom;

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Agent hereby agrees as follows:

1. Defined Terms. All capitalized terms used, but not otherwise defined herein, shall have the respective meanings ascribed in or otherwise referenced in the Security Agreement or the Patent Security Agreements, as applicable.

2. Release. The Agent, on behalf of the Secured Parties, without representation or warranty by or recourse to the Agent of any kind, hereby fully and finally releases, discharges, terminates and cancels all of its security interest in and to the Collateral, including the patents and patent applications set forth on Schedule I attached hereto (the "Patent Collateral"), arising under the Security Agreement and the Patent Security Agreements. If and to the extent that the Agent has acquired any right, title or interest in and to the Patent Collateral under the Patent Security Agreements, the Agent, on behalf of the Secured Parties, without representation or warranty by or recourse to the Agent of any kind, hereby re-transfers, re-conveys and re-assigns such right, title or interest to the Grantors.

3. Termination. The Agent, on behalf of the Secured Parties, without representation or warranty by or recourse to the Agent of any kind, terminates and cancels the Patent Security Agreements.

4. Further Assurances. The Agent agrees to take all further actions, and provide to each Grantor and its successors, assigns or other legal representatives, all such cooperation and assistance (including, without limitation, the execution and delivery of any and all documents or other instruments), reasonably requested by such Grantor, at such Grantor's sole cost and expense, to more fully and effectively effectuate the purposes of this Release, in each case without representation or warranty by or recourse to the Agent of any kind.

5. Governing Law. This Release shall be governed exclusively under the laws of the State of New York, without regard to conflicts of law or choice of law principles.
