RELEASE OF SECURITY INTEREST IN PATENTS

This RELEASE OF SECURITY INTEREST IN PATENTS (this "Release"), dated as of September 23, 2021 (the "Effective Date"), is made by U.S. BANK, NATIONAL ASSOCIATION, in its capacity as Administrative Agent for the Secured Parties (the "Agent"), in favor of NELSON GLOBAL PRODUCTS, INC., an Indiana corporation and WATER WORKS MANUFACTURING, INC., a Delaware corporation (each, a "Grantor" and collectively, the "Grantors").

WHEREAS, pursuant to that certain Pledge and Security Agreement, dated as of October 28, 2016, by and among MANCHESTER SECURITIES CORP. (the "Original Agent"), the Grantors and certain other parties thereto (the "Security Agreement"), the Grantors granted to the Original Agent, in its capacity as agent for the Lenders (as defined therein), a security interest in and to certain collateral;

WHEREAS, pursuant to the Security Agreement, the Grantors executed and delivered a Patent Security Agreement, dated as of October 28, 2016 (the "Patent Security Agreement") for recordal with the United States Patent and Trademark Office;

WHEREAS, the Patent Security Agreement was recorded with the United States Patent and Trademark Office on November 17, 2016 at Reel 040355 Frame 0252;


WHEREAS, the Original Agent, the Agent, the Grantors and certain other parties thereto entered into that certain Successor Agent Agreement, dated as of December 30, 2016 (the "Successor Agent Agreement"), pursuant to which the Agent succeeded to the rights and obligations of the Original Agent under the Security Agreement, Trademark Security Agreement and the other Loan Documents (as defined therein);

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Agent hereby agrees as follows:

1. Defined Terms. All capitalized terms used, but not otherwise defined herein, shall have the respective meanings ascribed in or otherwise referenced in the Security Agreement or the Patent Security Agreement, as applicable.
2. Release. The Agent hereby releases, discharges, terminates and cancels all of its security interest in and to the Patent Collateral, including the Patent registrations and applications set forth on Schedule I attached hereto, arising under the Security Agreement and the Patent Security Agreement.
3. Termination. The Agent, without representation or warranty of any kind, terminates and cancels the Patent Security Agreement.
4. Further Assurances. The Agent agrees to take all further actions, and provide to the Grantors and their successors, assigns or other legal representatives, all such cooperation and assistance (including, without limitation, the execution and delivery of any and all documents or other instruments), reasonably requested by the Grantors, at the Grantors' sole cost and expense, to more fully and effectively effectuate the purposes of this Release.
5. Governing Law. This Release shall be governed by, and construed and interpreted in accordance with, the law of the State of New York.
