CERTIFICATE OF AMENDMENT
OF CERTIFICATE OF INCORPORATION OF UBER ELEVATE, INC.**

Uber Elevate, Inc. (the "Company"), a corporation organized and existing under and by virtue of the General Corporation Law of the State of Delaware, hereby certifies as follows:

1. The name of the company is Uber Elevate, Inc., and the original Certificate of Incorporation of the Company (the "Certificate") was filed with the Secretary of State of the State of Delaware on February 6, 2019.
2. This Certificate of Amendment has been duly adopted and approved by the Board of Directors of the Company, acting in accordance with the provisions of Sections 141 and 242 of the Delaware General Corporation Law.
3. Article I of the Certificate is hereby amended to read in its entirety as follows:
"The name of this corporation is Joby Elevate, Inc."
4. Article VI, B. Section 5 of the Certificate is hereby amended to read in its entirety as follows:
"create, or authorize the creation of, or issue, or authorize the issuance of any debt security or create any lien or security interest (except for purchase money liens or statutory liens of landlords, mechanics, materialmen, workmen, warehousemen and other similar persons arising or incurred in the ordinary course of business or debt securities or liens in favor of Joby Aero, Inc. or its affiliates (collectively, the "**Joby Group**") or incur other indebtedness for borrowed money, including but not limited to obligations and contingent obligations under guarantees, or permit any subsidiary to take any such action with respect to any debt security lien, security interest or other indebtedness for borrowed money (except for equipment leases, bank lines of credit or trade payables incurred in the ordinary course or in favor of the Joby Group);"
5. Article VII, B. Section 3 of the Certificate is hereby amended by deleting each reference to "Uber Elevate, Inc." and replacing it with the text "Joby Aero, Inc."
6. Article VII, F. of the Certificate is hereby amended to read in its entirety as follows:
"Each member of the Board of Directors must be an officer or employee of the Joby Group."
