Pursuant to the provisions of Title 14A, Chapter 9 of the New Jersey Business Corporation Act (the "BCA"), the undersigned corporation adopts the following Certificate of Amendment to its Certificate of Incorporation (the "Certificate of Amendment").

1. The name of the corporation is: TCP RELIABLE, INC. (the "Corporation").
2. The following amendments to the Certificate of Incorporation of the Corporation (the "Certificate of Incorporation") were approved by the directors and thereafter duly adopted by the shareholders of the Corporation on June 22, 2020:

RESOLVED, that Article FIRST of the Certificate of Incorporation be amended and restated in its entirety to read as follows:

FIRST: The name of the corporation (hereinafter called the "Corporation") is:

RESOLVED, that Article FOURTH of the Certificate of Incorporation be amended and restated in its entirety to read as follows:
