

RESTATED CERTIFICATE OF INCORPORATION  
OF  
TOTEMIC INC.**

The undersigned corporation, pursuant to Section 242 of the Delaware General Corporation Law, duly adopts and hereby certifies the following:

FIRST: The name of the corporation is Totemic Inc. (the "*Corporation*").

SECOND: The Amended and Restated Certificate of Incorporation of the Corporation, as it was filed with the Delaware Secretary of State on October 6, 2017, as amended (the "*Certificate*"), is hereby further amended pursuant to written consent in lieu of a meeting of the Board of Directors of the Corporation, proposing and declaring advisable the following amendments to the Certificate, and a written consent in lieu of a meeting of the stockholders of the Corporation, in accordance with the provisions of Sections 228 and 242 of the Delaware General Corporation Law as follows:

1. Article I of the Restated Certificate, relating to the name of the Corporation, is amended and restated in its entirety to read as follows:

"The name of this corporation is Koko Home, Inc. (the "*Corporation*")"

2. The first paragraph of Article V is hereby amended and restated in its entirety to read as follows:

"The total number of shares of all classes of stock that the Corporation has authority to issue is (a) 11,500,000 shares of Common Stock, \$0.0001 par value per share ("*Common Stock*"), and (b) 4,548,985 shares of Preferred Stock, \$0.0001 par value per share ("*Preferred Stock*")."
