PATENT ASSIGNMENT AGREEMENT

This Patent Assignment Agreement (the "Agreement") is entered into as of April 25, 2016 (the "Effective Date") by and between Supertanks, LLC ("Supertanks"), on the one hand, and Viking Mold, Inc. ("Viking"), on the other hand.

WHEREAS, the Parties have entered into a Confidential Disclosure Agreement dated as of March 10, 2014, which agreement shall remain in full force and effect; and,

WHEREAS, Supertanks and Viking are developing a process and certain molding hardware that will allow Supertanks to mold certain sending unit sealing systems into the fuel tanks sold by Supertanks.

NOW, THEREFORE, in consideration of the mutual covenants and agreements hereinafter set forth and for other good and valuable consideration, the adequacy, sufficiency and receipt of which is hereby acknowledged, Supertanks and Viking (each a "Party," and collectively, the "Parties") agree as follows:

1. DEFINITIONS.

The following words and expressions shall have the meanings set forth below:

1.1 "Intellectual Property Rights" means: (i) all patent rights and all right, title and interest in and to all patents and applications for patents, and all other government-issued or granted indicia of invention ownership including any reissue, division, continuation or continuation-in-part applications; (ii) all trademarks, tradenames, service marks and logos, and all rights, title and interest in and to all applications, certifications and registrations therefore; (iii) all copyrights and all other literary property and works of authorship and author rights, and all right, title and interest in and to all copyrights, and copyrighted interests; (iv) all mask work rights; (v) all rights, title and interest in and to all trade secrets and trade secret rights arising under the common law, state law, or United States federal law; and (vi) all licenses or license rights relating to any of the foregoing.

1.2 "Inventions" means and refers to new and useful processes, devices, machines and improvements, including molding hardware, jointly conceived and specifically devised by the Parties in connection with the development of a process and certain molding hardware that will allow Supertanks to mold a sending unit sealing system into the fuel tanks sold by Supertanks.

2. ASSIGNMENT.

2.1 Viking hereby conveys, transfers and assigns to Supertanks any and all of its Intellectual Property Rights arising out of or relating to the Inventions, inclusive of all royalties, fees, income or other proceeds accruing, and any and all claims and causes of action with respect to any of the foregoing whether accruing before or after the Effective Date.

3. FURTHER ACTIONS.

3.1 Viking shall take such steps and actions, and provide such cooperation and assistance to Supertanks and its successors, assigns and legal representatives, including the execution and delivery of any affidavits, declarations, oaths, exhibits, assignments, powers of attorney, or other documents, as may be necessary to effect, evidence or perfect the foregoing assignment to Supertanks, or any of its assignees or successors.

5. MISCELLANEOUS PROVISIONS.

5.1 This Agreement shall be binding on and inure to the benefit of the Parties and their respective successors and permitted assigns.

5.2 This Agreement shall be governed by and construed in accordance with the laws of Idaho, without regard to its conflict of law provisions.

5.3 This Agreement constitutes and contains the entire agreement of the Parties, and supersedes any and all prior or contemporaneous negotiations, correspondence, understandings and agreements between the Parties, written or oral, respecting the subject matter hereof; provided, however, that the Confidential Disclosure Agreement dated as of March 10, 2014 remains in full force and effect.

5.4 This Agreement may be executed in one or more counterparts, each of which shall be deemed to be an original, but all of which together shall constitute one and the same instrument.


