## ASSIGNMENT

AND ASSIGNOR hereby covenants for himself and his legal representatives, and agrees with said ASSIGNEE, his successors and assigns, that ASSIGNOR has granted no right or license to make, use, sell or offer to sell the Patent Portfolio or any parts thereof, to anyone except said ASSIGNEE, that prior to the execution of this deed, his right, title and interest in the Patent Portfolio had not been otherwise encumbered, and that he has not and will not execute any instrument in conflict therewith;

AND ASSIGNOR does hereby authorize and request the United States Patent and Trademark Office, or any other authority of any other country, to issue any and all letters patent which may be granted upon the Patent Portfolio, or any parts thereof when granted, to said ASSIGNEE;

AND ASSIGNOR hereby agrees (a) to communicate to ASSIGNEE, its successors and assigns, or their representative or agents, all facts and information known or available to ASSIGNOR respecting said invention or inventions, improvements, and modifications including

evidence for interference, reexamination, reissue, opposition, revocation, extension, or infringement purposes or other legal, judicial, or administrative proceedings, whenever requested by ASSIGNEE; (b) to testify in person or by affidavit as required by ASSIGNEE, its successors and assigns, in any such proceeding in the United States or a country foreign thereto; (c) to execute and deliver, upon request by ASSIGNEE, all lawful papers including, but not limited to, original, divisional, continuation, and reissue applications, renewals, assignments, powers of attorney, oaths, affidavits, and declarations, depositions; and (d) to provide all reasonable assistance to ASSIGNEE, its successors and assigns, in obtaining and enforcing proper title in and protection for said invention or inventions, improvements, and modifications under the intellectual property laws of the United States and countries foreign thereto;

AND ASSIGNOR HEREBY REPRESENTS AND WARRANTS that ASSIGNOR has the full and unencumbered right to sell, assign, and transfer the interests sold, assigned, and transferred herein, and that ASSIGNOR has not executed and will not execute any document or instrument in conflict herewith.
