VELOUR hereby further agrees that it will communicate to LASH OPCO, or to its successors, assigns and legal representatives, any facts known to VELOUR respecting any improvements; and, at the expense of VELOUR, to testify in any legal proceedings, sign all lawful papers, execute all divisional, continuation, reissue and substitute applications, make all lawful oaths, and generally do everything possible to vest title in said LASH OPCO and to aid said LASH OPCO, its successors, assigns and legal representatives to obtain and enforce proper protection for said invention in all countries.
