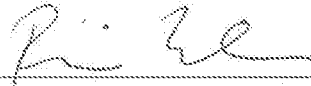
WHEREAS, Imerys Graphite & Carbon Switzerland Ltd., a corporation organized and existing under the laws of Switzerland, having a place of business at Strada Industriale, 6743 Bodio, Switzerland, hereinafter called the "Assignee", desires to acquire the entire right, title and interest in and to the invention and any future patent application and all patents, foreign and domestic, which may be obtained for said invention, as set forth below:

NOW, THEREFORE, for good and valuable consideration, the sufficiency and receipt of which are acknowledged, the Assignors have assigned and transferred, and by these presents do assign and transfer to the Assignee, its successors, legal representative and assigns (also collectively "the Assignee"), the entire right, title, and interest throughout the world to the invention and any patent application filed for this invention as identified above (including all provisionals, non-provisionals, divisionals, continuations, continuations in part, reexaminations, reissues and all other applications for any patent that shall be filed, issued or granted in any country on such inventions, including but not limited to utility models, designs, design patents, as well as envelope soleau and like rights of exclusion). This assignment and transfer also includes the right to claim priority based on the filing date of any patent application that will be filed for the above invention under the International Convention for the Protection of Industrial Property, the Patent Cooperation Treaty, the European Patent Convention, and all other treaties of like purposes; and all other rights, including without limitation, the right to sue for any past infringement of the Intellectual Property (collectively, the "Proprietary Rights") associated with the invention as defined above. Assignor authorizes the Assignee to apply in all countries in my name or in its own name for patents, utility models, design registrations and like rights of exclusion and for inventors' certificates for all inventions as defined above.

The Assignor shall, from time to time, execute and deliver to the Assignee, without further compensation, such additional instruments, documents, conveyances or assurances and take such other action as shall be necessary or otherwise reasonably requested by the Assignee to confirm and assure the rights and obligations provided for in this Agreement and render effective the consummation of the transactions contemplated hereby and thereby including, but not limited to the execution of all non-provisionals, divisionals, continuations, continuations-in-part, reexaminations, reissues, and all other patent applications on the invention; execute all lawful oaths, declarations, assignments, powers of attorney and other papers; communicate to the Assignee all facts known to the Assignor relating to the invention and the history hereof; and generally do everything possible

which the Assignee shall consider necessary for vesting title to the Proprietary Rights in the Assignee,
and for securing, maintaining and enforcing proper protection for the Proprietary Rights.
