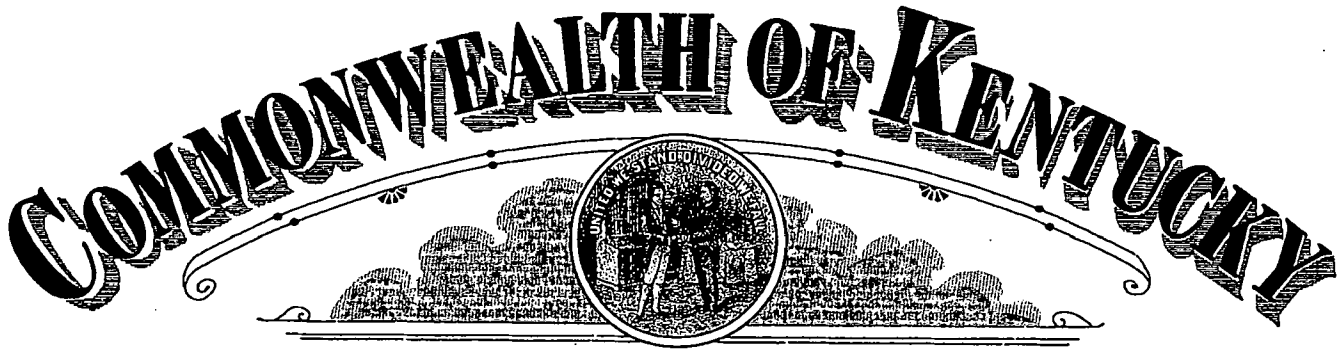


Article II: The mailing address of the limited liability company's initial principal office is 650 Three Springs Road, Bowling Green, KY 42104.
