CONFIRMATORY INTELLECTUAL PROPERTY ASSIGNMENT

This CONFIRMATORY INTELLECTUAL PROPERTY ASSIGNMENT (this "Confirmatory IP Assignment") is by and between StorageOS Ltd, a company organized under the laws of the United Kingdom (the "Seller"), and Akamai Technologies, Inc., a Delaware corporation having offices at 145 Broadway, Cambridge, Massachusetts 02142 ("Akamai").

WHEREAS, pursuant to that certain Purchase and Sale Agreement made March 29th, 2023, among Seller, Akamai, and Akamai Technologies International AG, a wholly owned indirect Akamai subsidiary (the "Agreement"), Seller transferred to Akamai all right, title and interest in "Company Intellectual Property", including "Patent Rights" and "Trademarks" (the latter including Internet domain names), as those terms were defined in the Agreement;

WHEREAS, the Patent Rights included without limitation the patents and patent applications listed on Schedule 1, the Trademarks listed on Schedule 2, and the Internet domain names listed on Schedule 3, all attached hereto.

NOW THEREFORE, for good and valuable consideration as set forth in the Agreement, receipt of which is hereby acknowledged, Seller confirms it has assigned, sold and transferred and conveyed unto Akamai, and otherwise does hereby assign, sell, transfer and convey unto Akamai, and its successors and assigns, Sellers' entire right, title and interest in the Patent Rights (including, without limitation, those on Schedule 1), the Trademarks (including without limitation those on Schedule 2) and Internet domain names (including, without limitation, those on Schedule 3), and the entire right, title and interest in and to any and all claims, demands, causes of action or the like Seller may have, either at law or in equity, arising out of any actual or alleged past, present or future infringement thereof.

This Confirmatory IP Assignment may be presented to appropriate government entities as needed to record Akamai's ownership of the Company Intellectual Property. In addition, Seller shall execute whatever additional documentation Akamai may reasonably request from time-to-time to establish and/or confirm Akamai's ownership of the Company Intellectual Property.

This Confirmatory IP Assignment is effective, now for then, as of March 29, 2023.

This Confirmatory IP Assignment may be executed in any number of counterparts, each of which shall be deemed an original but all of which together shall constitute one and the same instrument.



