

This Patent was previously assigned to Inventus Holdings, LLC by the inventors Rick D. Degelau and Robert L. Manson, with such assignments recorded on June 15, 2018 at Reel / Frame: 046103 / 0259 at the United States Patent and Trademark Office. However, in the process of recording the assignments, a clerical error resulted in Florida Power & Light Company being incorrectly designated as the assignee of record, and as a result, within several databases populated with USPTO data. Inventus Holdings, LLC and Florida Power & Light Company are both subsidiaries of NextEnergy, Inc. The purpose of executing and recording this Inter-Company Patent Assignment is to correct the clerical error that resulted in the incorrect designation of Florida Power & Light Company as the assignee of record. Further, the assignments by the inventors Rick D. Degelau and Robert L. Manson are concurrently being re-recorded with the correct designation of Inventus Holdings, LLC as the assignee.
