**THIRD AMENDMENT TO
INTENSITY ANALYTICS CORPORATION
INTELLECTUAL PROPERTY SECURITY AGREEMENT**

This THIRD AMENDMENT TO INTELLECTUAL PROPERTY SECURITY AGREEMENT (this *Agreement*), dated as of April 16, 2023, is made by INTENSITY ANALYTICS CORPORATION, a Delaware corporation (the "*Borrower*"), in favor of BRUCE RUBINGER, in his capacity as collateral agent (the "*Collateral Agent*"), pursuant to the Collateral Agent and Intercreditor Agreement (as defined below), for the purpose of amending the Intellectual Property Security Agreement dated June 29, 2020, as amended by the First Amendment to said agreement dated December 17, 2020, and the Second Amendment to said agreement dated October 27, 2021 (as amended, the "*IP Security Agreement*").

WHEREAS, on June 29, 2020, the Borrower entered into a Secured Loan Agreement and Promissory Note with three lenders (collectively, the "*Creditors*"), and on December 17, 2020, entered into a new Secured Loan Agreement and Promissory Note with one of the Creditors.

WHEREAS, pursuant to the terms of the Collateral Agent and Intercreditor Agreement, dated as of June 19, 2020, the Collateral Agent is authorized to act for the Creditors.

WHEREAS, on June 29, 2020, the Borrower and the Collateral Agent entered into the IP Security Agreement, whereby the Borrower granted to the Collateral Agent a first priority security interest in its intellectual property to secure repayment of the Secured Loan Agreement and Promissory Notes issued to the Creditors on that date.

WHEREAS, on December 17, 2020, the Borrower and the Collateral Agent entered into the First Amendment to the IP Security Agreement, and on October 27, 2021, the Borrower and the Collateral Agent entered into the Second Amendment to the IP Security Agreement.


WHEREAS, the Borrower and the Collateral Agent now wish to amend the IP Security Agreement to replace the current Exhibit A to the IP Security Agreement with a revised Exhibit A that includes a new patent application filed by the Borrower on January 9, 2023.

NOW THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the parties agree as follows:


1. Attached is Revised Schedule A, which replaces the original Schedule A currently attached to the IP Security Agreement.
