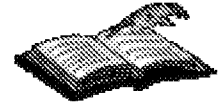

subject matter directly or indirectly related to the patent application and the invention) and formal applications based thereon;


