TERMINATION AND RELEASE OF SECURITY INTEREST IN PATENT RIGHTS

TERMINATION AND RELEASE dated as of October 24, 2014, from JPMORGAN CHASE BANK, N.A., as collateral agent (the "Agent") to MOMENTIVE PERFORMANCE MATERIALS INC., a Delaware corporation (the "Pledgor").

WITNESSETH:

WHEREAS, pursuant to the U.S. Collateral Agreement dated as of December 4, 2006 (as amended, restated, supplemented or otherwise modified from time to time, the "Collateral Agreement"), made by the Momentive Performance Materials Holdings Inc., Pledgor, certain subsidiaries of Pledgor listed therein in favor of the Agent, a security interest (the "Security Interest") was granted by the Pledgor to the Agent in certain collateral, including the Trademark Collateral;

WHEREAS, pursuant to that certain Patent Security Agreement dated as of March 8, 2012, among the Agent, Pledgor and the other Grantors party thereto (the "Security Agreement"), Pledgor, by reference to the Collateral Agreement, reaffirmed its intent to grant the Security Interest to the Agent specifically in certain Patent Collateral (including, without limitation those items listed on Exhibit A hereto);

WHEREAS, the Security Agreement was recorded in the Patent Division of the United States Patent and Trademark Office on March 28, 2012 at Reel 027944 and Frame 0386; and

WHEREAS, the Agent now desires to terminate and release the entirety of its Security Interest in the Patent Collateral;

NOW, THEREFORE, for good and valuable consideration, the receipt and adequacy of which are hereby acknowledged, and upon the terms set forth in this Termination and Release, the Agent hereby states as follows:

1. Definitions. Capitalized terms used in this Termination and Release and not otherwise defined herein have the meanings specified in the Security Agreement.
2. Release of Security Interest. The Agent hereby terminates, releases and discharges, without recourse, representation or warranty, its Security Interest in the Patent Collateral, and any right, title or interest of the Agent in such Patent Collateral shall hereby cease and become void.
3. Further Assurances. The Agent hereby agrees to duly execute, acknowledge, procure and deliver any further documents and to do such other acts as may be reasonably necessary to effect the release of the Security Interest contemplated hereby.
